Sarah Agnew Myers, 4 Myers Ave., Trion, Ga:

PROBLEM: Who is this JOHN AGNEW, who seems to have Agnew connections, according to the first four transactions? (assuming it is the same Agnew getting the land)

My first idea that he was the son of GEORGE AGNEW, REV. SOL., I think was wrong. Why?

- 1. If the birth dates for GEORGE-1762 and JOHN-1776 are right, that would make GEORGE pretty young to be married and have a son, or even a son out of wedlock.
- According to my research, GEORGE had a son named JOHN about 1800-01 soon after he went to Lincoln Co., KY. GEORGE AGNEW can be traced to Maury Co., TN and later to Washington Co., AL (from which place his third letter seeking his pension was written) and eventually to Lauderdale Co., MS where he died. GEORGE's son JAMES, b 1783, married and raised a family in the AL-MS area. Also MARGARET AGNEW, George's daughter born in 1786 (m. 1809 to Darlington Hall in Maury Co. TN and years later m. William son, JOHN AGNEW, born ca 1800, married in MS Henderson). Another 1826 and raised a family in the area. A plat of Butler Township, AL, no date, shows living in adjacent lots John and Samuel Agnew, (5 Nov 1834, William Henderson, two lots, 29 Jan 1819 and Oct 18, 1834, and James Agnew, 12 March 1835).
- 3. This JOHN AGNEW would not be George Agnew, Rev Sol's brother because John Agnew and Elizabeth's George Rev. Sol. was John's "eldest son", so noted when he was made administrator of John's will. He (the John Agnew in question) would have been too young to hold land if he had been a younger brother of George, Rev. Sol.

RESEARCH RE: GEORGE AGNEW, REV. SOL. by Jean Agee, Richburg, SC:

GEORGE AGNEW applied for Administration 20 Dec 1783. "No Return" Administration Bond: George Agnew, Administrator, John Barber, bound to Henry Hampton, Ordinary of Camden District....for 3000 sterling... 10 Jan 1784.

Researchers of this GEORGE AGNEW FAMILY need to keep in mind that in both SC and GA this family had members who lived in adjoining counties, had children born in different counties. It may be necessary to check both counties to get accurate info. Chester and York cos. in SC; and Chattooga Co. GA and Cherokee Co., Ala. The GEORGE AGNEW home in Ala. was just a mile or so over the Ala line and most of the Agnew "kin" lived in Chattooga Co, GA.

According to letters home from William Green Agnew (s/o George Agnew), his first cousin, Calvin, had a leg wound which required amputation of his leg, and he never recovered. The cousins saw each other occasionally, John Anderson (s/o Elizabeth A. Anderson) was in the same unit with Calvin.

According to family tradition, both oral and written, Margaret and Mary Zella Agnew married brothers William and Zachariah Westbrook. A descendant, Jean Westbrook Gibbons, who lives in Arlington, TX, noted that the Jarrett Westbrook and John Agnew households in the 1810 Chester, SC census were only two households apart.

Margaret "Peggy" Agnew and William Westbrook married first, going to live in Miss. Some ten years later Mary "Polly" Agnew and Zachariah Westbrook were married and lived in Miss. One family tradition says that Zachariah went back to Chester, SC to marry his sweetheart. Both Westbrook families as well as another Westbrook brother went to Navarro Co., TX where there have been Westbrook descendants down to the present.

A WESTBROOK Family History, written by Middleton Westbrook in the 1920's tells of memories of Mary Agnew Westbrook which were written aunts of Mrs. Jean W. Gibbons. down by two maiden "She was the Her three brothers were George, voungest of four daughters. The oldest brother moved to GA and died there William and John. while the two others spent their lives in SC. The three other Agnew sisters were: Betsy who married John Anderson and spent her life in SC; Jennie who also married and lived in SC; and Margaret who married William Westbrook and became a citizen of Texas."

Other bits and pieces help substantiate the Agnew family relationship of Mary and Margaret to John Agnew and Catherine Steel Agnew. Some ten years ago Mrs. Gibbons saw a letter to Mary Zella from "J.S. Agnew"; Another bit of information about the Agnews that has survived through the years that "Betsy lived to be 96 years old". "Betsy" didn't live that long but did live to be quite old. Another relative told of a high school student writing his family history who told of the three sisters and three brothers of Mary. "the oldest son, either John or George, moved to Georgia and had a large family near Rome, Ga. their cemetery lot in Rome, Ga. is near Woodrow Wilson's first wife's burial plot". (A son of Mary's brother is buried in that plot in Rome, Ga's Myrtle Hill Cemetery.)

### Setting the Record Straight about Isaac McFadden, Sr.

by Emily Croom, a descendant

This compilation is offered to set the record straight that Isaac McFadden Sr. of Chester County had two wives and sixteen known children and to provide the documentation for the first wife and her ancestry.

#### Facts About Isaac McFadden's Life

- 1. We do not know conclusively who Isaac's parents or grandparents were. There is speculation, and there were several McFadden families in the area of South Carolina where Isaac lived. No one has been able to link him with any of these families with *proof* from contemporary documents. In my opinion, circumstantial evidence alone is not enough to link him with one family if the others are not studied. It is also not known where Isaac was born-Northern Ireland, Pennsylvania (a port of entry and temporary stop for many who made their way to the Carolinas), or South Carolina. Isaac had sons named Robert, John, Candor, and Ralph-all names of early McFaddens in the Chester District area of South Carolina.
- 2. It is thought that Isaac had a sister Mary McFadden (11 Dec 1757-27 June 1836) who married Samuel McKinney. Her descendants believe she was born in Northern Ireland. She had children named Robert, Isaac, Samuel, Ewin, and Jennet. If she was born in Northern Ireland and was Isaac's sister, then Isaac too must have been born in Northern Ireland, along with many of his South Carolina neighbors. They may, on the other hand, have been born in the colonies.
- 3. Isaac McFadden supported the colonial cause in the Revolution. In the effort, he lost a horse and saddle, appraised at 107 pounds old currency, while in "publick service" at the Battle of Fishing Creek, 18 Aug 1780. [See SC Audited Account AA5038, Stub Indent Y-151, from South Carolina Archives. See also Stub Indent R-589 to connect Isaac with Francis Marion's men.] Isaac also served under General Thomas Sumter, in Colonel Henry Hampton's Regiment with Captain John Mills' Light Dragoons.
- 4. Isaac married Elizabeth Steele about 1782, when he was about 28 and she, about 19. [based on birth of first child in 1784]
- Isaac and Elizabeth were Presbyterians.
- 6. Isaac apparently valued education and kept a small library of books. [See estate inventory.]
- 7. Isaac owned at least 742 acres of land and 9 slaves when he died in 1820. [In the estate division, sons Candor, Ralph and Harvey Davies each received about 114 acres; the remaining 400 acres were split among the younger daughters.]<sup>2</sup>

Isaac's wives' and children's names come from the McFadden-Patton-Coleman Bible record [family of Isaac and Elizabeth only] and from Isaac's will. Birth dates of Elizabeth's children come from the same Bible record and from descendants. Births of Mary's children come from descendants and calculations from cenus records. Marriage dates come from descendants and estimates from birthdates of children. Death dates come from cemetery records, McFadden-Patton-Coleman Bible record, and descendants. Spouses' names come from descendants and census records.



### McFadden-Patton-Coleman Family Bible

This family Bible is the New Testament volume of a five-volume set of Scott's Bibles, published in 1809 in Philadelphia and sold on subscription. The subscribers' list includes three McFaddens: James, Colonel Thomas, and Isaac. In fact, the inventory of our Isaac McFadden's estate after his death in 1820 shows a five-volume set of Scott's Bibles. In 1830, after his second wife, Mary, died, the estate sale list included the set of Bibles, purchased by son-in-law Thomas Patton (and his wife Catey McFadden) for \$12.12½. In the late nineteenth century, the Bible passed to their daughter Margaret Catherine (Patton) Coleman, wife of Elliott Glenn Coleman, of Hardeman County, Tennessee.

At least five individuals made the genealogical entries in the Bible record. The earliest entries are the births and deaths of the children of Isaac and Elizabeth (Steele) McFadden and the death of Isaac's wife Elizabeth. A different handwriting recorded Isaac's death. Another hand, probably of Thomas or Catey, entered the marriage of Thomas and Catey Patton and the births of their children. Their daughter Catherine Patton Coleman entered the deaths of her parents and siblings. Her son, Turner Coleman, entered the births of his children. The first that we Coleman cousins knew of any Patton and McFadden ancestry was on 5 May 1971, when K. Word Coleman copied the family record at the home of his sister Norma Irene Coleman McGary. Norma died eleven days later, and the Bible was not seen again until August 1996. It was located by Turner's youngest son, H.T. Coleman, and sent to the author. The Bible now lives in a safety deposit box in an archival container.

His tombstone apparently (I've not seen the original) says he died in his 67th year; thus most people give him a 1753-1754 birth year.]

### Abstract of the Will of Isaac McFadden, Sr.

Chester County, SC, Will Book 2-G, p 50 Notes in brackets added.

I, Isaac McFadden, "feeling the firmities of old age and the wastes of disease making progressive advances upon my bodily frame, yet possessing a competent soundness of mind, do conceive it to be dutiful to make the annexed arrangement of my worldly concernments."

I "commend my Soul to God (from whom it was received) resting on the efficacious mediation and merits of our glorious redeemer; and my body to be committed to the dust in a decent and christian manner, without parade or unnecessary expense in the hope of the resurrection from the dead, the reunion of Soul and body and the final admission of both into the abodes of bliss in the immediate presence and enjoyment of God."

After requesting the payment of debts, Isaac divided his property among his family: "relative to the portion of earthly property with which an indulgent Providence has placed under my stewardship, over and above what may discharge the above demand against me, it is my will that it be disposed of agreeable to the following arrangement:"

- 1. To my well-beloved wife Mary, all land on the Western fork of a branch heading near Wylie's pond and running north to the east of my present dwelling until it empties into the main branch which separates my land from Isaac McFadden Jr to use during her life or widowhood.
- 2. After Mary's marriage or death, the property to be divided equally between my four daughters Elizabeth Steele McFadden, Juliana Susanna, Sally, and Anne.
- 3. Daughter Catharine Ewing McFadden [married to Thoma Patton] to receive 1 negro girl Eliza and \$250 at my decease.
- 4. Sons James, Robert, Isaac, John, and Thomas to receive \$100 each to be paid at the death or marriage of my wife.
- 5. Son William to get lands bounded by Major Greene, Isaac McFadden Jr, et al, part of a tract originally granted to Thomas Farrel for 150 acres. Also William to get \$150 at my decease.
- 6. Sons Candor, Ralph, and Harvey to get the rest of the plantation on which I live, on the east side of the aforesaid branch.

Executors of the will: James Ewing McFadden and Isaac McFadden Jr. Signed by Isaac McFadden, 15 Feb 1818.

Probated in Chester County SC, 8 Jan 1821.

On 7 May 1821, E. Syles, ordinary of Chester District, authorized James and Isaac McFadden to sell the estate on credit of 12 months, cash if the purchase was under \$5.

First documented evidence of Elizabeth as wife of Isaac: Chester County SC Deeds, Book B, p 85, 10 June 1789. Isaac and wife Elizabeth of Chester County were selling to John Ferguson 246 acres on Fishing Creek, part of a 350-acre grant to Robert McFadden, now deceased, dated 26 July 1774. Witnesses: David Hunter, Ralph McFadden, Candor McFadden. Isaac signed his name; Elizabeth made her mark.

Proof of Elizabeth's maiden name and parentage: Jones County NC Deeds, Book G, p 154-155, 11 Feb 1790. Copy from NC State Archives. Isaac McFadden of Chester County SC was selling to David Ventress of Jones County NC. for thirty pounds, 33 1/3 acres, part of a tract of 100 acres on south side of Trent River, bounded by lands of Pollock, Collins, Lee, & Knott, originally granted to John Lee and devised by him to his daughter Fanny Steel and her husband James Steel during their lives and then to their son John Steel and his heirs, but fell to the daughters of said James Steel, viz Mary Steel, Elizabeth Steel (the wife of said McFadden) and Aseneth Steel. Isaac signed. Elizabeth made her mark. Witnesses: Andrew Couser (?), Elijah Steel. Presented in Jones County NC court, May 1793.

Proof of Elizabeth's grandfather: Jones County NC Deeds, Book G, p 358-359, 10 May 1794. David Ventress and Isaac McFaden [sic] were selling to John Burton Lee of Jones County NC, for thirty pounds paid to Ventress, their interest in land patented by John Lee, grandfather to the wives of the said David & Isaac dated April 22nd 1767 (part of land description torn off of original). David made his X. Mary Ventress, his wife, signed. Witnesses: Nicholas Booty, Richard Foscue (?).

Proof of Steel ancestry: Jones County NC Deeds, Book G, p 147-148, 1 Feb 1793. Alexander Steel of Washington County GA was selling to Elijah Steel of Jones County NC, for forty? pounds sterling, 52 acres, part of a tract of 230 acres in Jones County, on south side of Trent River, joined by lands of Durant Hatch & John Newton (?), originally devised by will by Alexander Steel, the grandfather of first-mentioned Alexander and Elijah, to Peter Steel their father and devised by will by said Peter Steel to his four sons: the aforesaid first-mentioned Alexander Steel, the aforesaid Elijah Steel, Benajah Steel, and James Steel. Alexander was selling his share to his brother Elijah. [The last part of the deed is missing from the copy sent to author by North Carolina State Archives.]

Further proof of Steel ancestry: Jones County NC Wills, Will Book 1, p 185, Will of Peter Steel, dated 1 Jan 1792. Copy from North Carolina State Archives; capitalization and spelling are of the original.

"In the Name of God Amen. I Peter Steel Jones County and State of No Carolina being of sound mind and Perfect Memory (Blessed be god) do this first Day of January in the year of Our Lord One Thousand Seven Hundred and Ninety Two, make and Publish this my Last Will and Testament, in Manner following that is to say--

First I Give Unto Martha my Beloved Wife the Use of one forth of my Land Concluding [sic] the Plantation Where I now Live Untill my son James Comes of Age.

Item. I Give Unto my Son Alexander One Forth of my Land Begining at the Corner next to John Eubanks to him His Heirs and Assigns forever.

Item. I Give Unto my Son Benejah one forth of my Land Where he now Lives to him his heirs and Assigns forever.

Item. I give Unto my son Elijah one forth of my Land Next to Durant Hatch the upper Part of my Land to him his Heirs and Assigns forever.

Item. I give Unto my Son James one forth and fifteen \_\_\_\_? More to be Taken of the Upper Part to him his Heirs and Assigns forever.

Also I give my son James When he Arives to the Age of Twentyone a Horse that Shall be Worth Twentyfive Pound to him Heirs and Assigns forever.

My Will and Desire is that all the Remainder of my Estate Should Continue in the Hand of my Af'd Beloved Wife Untill Either of my Daughters Sarah Rachel Mary or Rebecah Should Marry then to be Equally Divided Between my Beloved Wife Martha and my fore above mentioned Daughters to them their Heirs and Assigns forever—if Either my Daughters Should Die Before they Marryeth that their Part Should be Equally Divided between the Remdr of my Children. I Hereby Make and ordain My two sons Benejah and Elijah and Lem'l Hatch Esqr Executors to this my last Will and Testament. I[n] Witness Whereof I the said Peter Steel have to this my Last Wil and Testament Set my Hand and seal the Day and year Above Written. Signed Sealed and Declared by the said Peter Steel the Testator as his last."

Peter signed with his mark: PS. Witnesses: Dur't Hatch, Jas. Cleary, Lemue Lipay. Produced in court of Jones County, February term, 1792.

"in the name of God amen I Alexander Steell of Onslow County planter, being sick and weak in Body but of Sound and disposing mind and memory do make this my last will and testament in form following, cheife of all, I commend my Soul into the mercies of God my maker through Jesus Christ my Redeemer, and my Body to earth to be decently intered at the discression of my Executor, and as for such worldly goods as providence has trusted me with (after my just debts and needfull expences are first satisfied and payd) I dispose of the same as followeth — —

imprimis [first] I will and bequeath unto my two sons peter and James my plantation on Trent river as also my negro Boy called Tony to be equally divided between them to my said Sons peter and James and each of their heirs, and assignes for ever,





### CHPISTMAS

### ON A SOUTHERN PLANTATION

In striking contrast to the rigorous pioneer life in Indiana where my grandparents lived, Mrs. Elizabeth Roseborough Dyer (born 1878), daughter of John Calhoun Roseborough and granddaughter of William Daniel Rosborough, of Sardis, Mississippi, wrote me recently (1965) of the plenty and luxury on her grandfather's plantation, where she and her family often spent Christmas and other special days when she was a girl. I quote from her account, ---

"As soon as Christmas Festivities were over, everyone began to make things for the coming year and next Christmas. The old mule worked the cotton gin. Darkies carded the cotton and wool. Spinning wheels for cotton, wool and flax spun threads for new materials. Looms were busy weaving new fabrics for the family clothes, even some for friends and the darkies.

The making of Christmas gifts was begun early, for this took lots of time. Favorite gifts were crocheted bed spreads, doilies, needlepoint, point lace and antimacassars. Ladies worked many months producing such artistic luxuries. Thus the summer melted away on the plantation, and another Holiday Season rolled around.

After Thanksgiving celebrations were over, Christmas preparations began in earnest. Christmas cakes and puddings were baked or steamed, and put away in oiled paper to ripen, with the addition of Scupernong Wine for delicious flavor. Great piles of wood were cut, to make roaring fires in the fireplace in each room. Pantry shelves had been filled with jams, jellies, preserves and pickles. From the abundant Scupernong and Muscadine grapes, quantities of wine had been made. In late fall apple cider was bottled in jugs. Sweet potatoes had been banked, ready to use.

A week before Christmas, Jake and Old Moses went to the woods to cut down the prettiest Holly tree they could find. They brought in plenty of greenery to decorate the house, and mistletoe to hang in the doorways. They also cut the largest Yule log they could find for the front parlor fireplace on Christmas Day. As long as that log burned, no work was done by the darkies on the plantation, unless absolutely necessary.

When I was a child our family always had a reunion at Christmas at my grandfather William Daniel Rosborough's Plantation at Sardis, Mississippi. As I look back on those happy days, I remember clearly every detail of our visits. We lived only eight miles away, and made the trip to Grandfather's on Christmas Eve in horse drawn carriages.

The long winding drive on the grounds leading to the house was beautiful with blooming flowers on both sides, with roses blooming in protected places. We clapped for joy when the stately, beautiful home came into view, with its porticoes and massive columns. In the front yard, the yellow Jasmine and Tea Olives perfumed the air. Holly and pine trees were everywhere; also Sweet Bay, Myrtles, Mimosas, Magnolias, and Smilox. The balmy air and singing birds added to the fairy scene.

We ascended the steps as grandparents and aunts came out to greet us, and the visiting began. An aunt took us into the back yard, where the darkies were stirring the last of the molasses, and sugar-cane svrup in long wood lined vats, singing as they worked. As the smoke house door was ajar, we looked in and saw meat hanging from the rafters, being cured by the smouldering fire of hickory wood.

At supper time we entered the large dining room, with its long white table decorated with white peonies and red chrysanthemums, with red candles on either side. The table was filled with delicious food, with plates of hot biscuits coming in every few minutes. The biscuits were covered to keep them warm in the long passage-way from kitchen to dining room.

After our dessert, we all went into the front parlor, with its elegant furniture upholstered with French tapestry and cabinets filled with treasures. In the light of the fireplace fire, our ancestors' portraits smiled down at us. My aunt sat at the square rosewood piano, playing lovely old songs and carols, which we all sang.

At dusk the darkies from the 'quarters' came up, and sang spirituals and carols, accompanied by their banjoes. This was the sweetest music of which the human voice was capable, and we all went out on the porch to listen. When they finished singing, they were treated to fresh apple cider poured from jugs into the cups they had brought with them. There was plenty of cake too. After a few more songs, the darkies left, some to go to the night watch.

We went to bed early, to be rested for the big day tomorrow. Before starting to bed, we caught everyone's 'Christmas Eve Gif',' Then our nurses, Dolly and Blossom, took us up to our rooms and put us to bed. That joyous Christmas peace which filled the hearts of all, settled serenely over the plantation.

Early Christmas morning Jake came in with kindling and wood for our fireplace, and started our low burning fire. Dolly came with a pitcher of hot water for our wash stand, then helped us to dress. Both of them caught our 'Christmas Gif', and we could hardly wait to catch someone else. As we went downstairs, we heard some darky saying, 'Christmas Gif', Ole Massa, Christmas Gif', Ole Miss."

We went into the back parlor, with its stuffed horse-hair sofas and chairs. In the corner was the beautiful Holly Christmas tree, agleam with tinsel, bright ornaments and strings of popcorn. There were piles of gifts under the tree, and hanging from the mantle and chairbacks were stockings fille, with fruit, candy and toys. There were plenty of firecrackers and Roman candles for everyone. After playing briefly with our toys, we went in to breakfast. What a feast it was, more like a wedding breakfast.

The breakfast table was gaily decorated with Smilox and holly. In the center a bunch of mistletoe was surrounded by holly. The food included platters of fried chicken, sausage and venison. There were snowy hominy, muffins, plenty of hot biscuits with marmalade and preserves, and steaming hot coffee.

After breakfast we examined our toys more closely. We enjoyed the kaleidoscopes with their beautiful designs and colors. Stereoscopes, with pictures of foreign lands and fabulous places, held our interest.

Then the darkies came in from their quarters, dressed in their Sunday best. Each family brought a small gift for 'Ole Massa' and one for 'Ole Miss.' They came in the back way, walked slowly through the long hall, to where my grand-mother was sitting, with grandfather standing beside her,

surrounded with gifts for the darkies. As each name was called, families came forward to receive oranges, bananas, candy and raisins, dress and trouser materials, toys for the children, and plenty of fireworks. It wouldn't be Christmas without fireworks. These gifts were received with a curtsy and, 'thank you,' and another 'Merry Christmas.'

One Christmas morning one of the darkies brought a live chicken as a gift to my grandfather. As he handed it to him, the chicken got loose and flew around over the hall. There was much excitement as everyone tried to catch it. This added to the merriment of that day.

Soon Dolly and Blossom took the children to the Lumber Room to play. We climbed the spiral staircase and went to a large room at the back of the house. In one corner were nuts of every kind, chestnuts, black walnuts, hickory nuts, chinquapins (dwarf chestnuts), scaly bark (hickory nuts), and goober peas (peanuts.) In another corner were apples, crahapples and persimmons. There were chests of drawers, filled with the finery of past generations. Blossom helped the boys to dress in satin knee-pants and lace frilled coats, while Dolly dressed us girls in party dresses, with hoop skirts, bonnets and slippers. Then we played at parties and dances. We were very elegant!

Our Christmas dinner was memorable. Wild turkey with chestnut dressing, roasted mallards, pork and venison. There

were snowy pyramids of rice, sugared yams, beaten biscuits, jellies, fruit cake and puddings. Wine was served to the grown-ups. What a banquet it was! Eggnog and sylabub were served with cake to visitors who came to call.

Dolly took us down to the 'quarters' after dinner, to see the darkies' cabins. The rooms were papered with newspapers. The woodwork around doors and windows was freshly whitewashed, and greenery decorated everything. As we entered the Parson's cabin, we heard him telling Christmas stories to children. He said, 'Come on in an' set with us. We is powerful proud yo'all is come down to see us. You pickaninnies set over dere on de floor, an' let de white chilluns set on de benches.' So we all sat there awhile, watching the colored 'chilluns', with their bright eyes and shining faces, listening to the Parson telling stories.

Back at the house, there was more enjoyment of toys, more visiting, and of course. the shooting of the fireworks. We went to bed a little sadly, for tomorrow we must leave all this. to return home---

Love,
All of the Roseboroughs"

### "Christmas Gift"

On Christmas mornings in our home my father would rise early and start the fires in the stoves to warm the house. Then he would go to the bedrooms, open the doors slightly and call "Christmas Gift." It was a greeting unaccompanied by any gifts, and started the day cheerily.

I did not then question him about the origin of the custom. The story of Christmas On A Southern Plantation, by Mrs. Elizabeth Roseborough Dyer, presented earlier, gives a clear picture of the origin and use of this southern custom. The recollection gives me a feeling of closer relationship with our southern cousins. It is a small world, isn't it?





Marker In the Southeast portion of Section 2, Bethesda Cemetery, Senatobia, Tate Co., MS.




#### BETHESDA CEMETERY US Hwy 51 - Senatobla, Tate Co., MS

#### BISHOP THEODORE DUBOSE BRATTON

Submitted by: William R. Shelton, Jr., 1131 Westwood Ave., Columbia, OH 43212:

Theodore DuBose Bratton was born on Roseland plantation, November 11, 1862, near Winnsboro, S. C., the son of General John Bratton, of the Confederate army, and Elizabeth Porcher DuBose Bratton.

In his early youth T. D. Bratton was educated by an aunt, and in 1874 entered the Grammar School of the University of the South at Sewanee, Tennessee. His university studies were interrupted when he had to return home for two years to manage his father's plantation while General Bratton directed the Democratic campaigns for South Carolina offices. Upon returning to Sewanee, he took up teaching duties and served as a proctor of the University while attending classes. Continuing his professional activities, he entered the theology school in 1884 and graduated in 1887; D.B., 1890. (PBK, ATO)

His first active duties were in York, Lancaster and Chester counties, S. C. where he acted in the capacity of a missionary for a year. From 1888 until 1903, his duties included being rector of the Church of the Advent, Spartanburg, S.C.; a tenure as professor of history of Converse College, Spartanburg; rectorship of St. Mary's School for Girls at Raleigh, N.C.; the position of examining chaplain as a diocesan head; membership on the standing committee, and a post as delegate to the church's General Convention.

On September 29, 1903, he was consecrated in St. Andrew's Church, Jackson, Miss., Bishop of Miss. He retired in 1938.

Theodore DuBose Bratton was in Y.M.C.A. service with our army in Europe, 1918-\_\_?. He was Chaplain General of the United Confederate Veterans in 1930. He served several years as a member of the national board of missions of the Protestant Episcopal Church. He was a long-time member of the Board of Trustees as well as Chancellor of the University of the South, 1936-38.

Bishop Bratton received an honorary D.D. from the University of the South, 1901; L.L.D. from the Univ. of Miss, 1911.

He was the author of "An Apostle of Reality", a tribute to his uncle, the Rev. William Porcher DuBose.

He died June 25, 1944.
