## SAMUEL GUY (GAY) AND HIS DESCENDANTS

Samuel Guy (Gay)—great great great grandfather  
William Guy (Gay)—great great grandfather

As the above outline shows, I am a sixth generation descendant of Samuel Guy (Gay). As an amateur genealogist I have, for the past five years, been compiling data as I was able to find it – then assembling in order and, in certain cases, drawing conclusions that were evident. It has become a sort of hobby – giving me a chance to visit many places of interest, talk to people, and in general be able to project myself backward into the periods in which these ancestors lived, while attempting to understand the “whys and wherefores” of their moves through the years. This kind of research is very rewarding. It teaches patience and perseverance. The house has been built block on block. Now it has reached a stage where I want to share it with those who are interested in the same line of ancestry.

The earliest known Guy in York County, South Carolina was Samuel – who as Samuel Gay was given a grant of land by George the Third of England in 1766. Record of this grant of land is in the State Archives located in Columbia, S. C. The 1790 census (first taken) lists him as Samuel Guy – head of the family with three males under sixteen years of age, seven females and two slaves. His will was probated in York County, S.C. in 1799 giving his name as Gay. He named daughters Mary Gay, Rebecca Walker and Jane Gay; sons-in-law John McConnell and James Hemphill; grandsons Robert G. McConnell, James G. Hall Gay, and William Newton Gay; and granddaughter Esther Hemphill.

In the National Archives (Washington, DC) I found a book – “Tennessee and King’s Mountain Papers”, issued by the Wisconsin State Historical Soc.- that contained an account of a celebration, in 1839, of the “Battle of Huck’s Defeat”- a battle of the Revolution fought on July 12, 1780 at Williamson’s Plantation, Brattonsville Dist. York Co. SC. A list is given of those whose memory was honored. William Guy, John McConnell

and James Hemphill were among those honored. This was my first clue to the identity of Samuel's son. Howe's "History of the Presbyterian Church" lists William Guy as head of a family on the membership roll of Bethesda Presbyterian Church, York Dist. SC, at some time between 1760 and 1785. This was my second clue.

I had always heard that the original Guys came into SC from the state of Pennsylvania and were of Scotch-Irish descent. The interchangeable names of Guy and Gay presented a challenge. From a correspondence (1921) between Dr. J. Sam Guy (now deceased) of Atlanta, Ga., and Boatwell Dunlap of California, I learned that the Samuel Guy (Gay) of York Co. SC could be the Samuel Gay of Augusta County, Va., as recorded in Mr. Dunlap's "History of the Gays of Augusta County, Va."

So—in October 1960, armed with this document and accompanied by Sally Dunn Guy, of Richmond, Va., I went on a search of Hays of Augusta County. As my document contained much courthouse data, we specialized in the searching of church and cemetery records. The original Augusta County covered what is now about six counties. Our ultimate reward came on our last stop which was at the Tinkling Spring Presbyterian Church — located at Fishersville, Va. (near Waynesboro). In the churchyard we found a large marble shaft on which the name of Samuel Gay appeared as one of the men who had contributed to the fund collected for the building of the first church in 1740. No Hays were buried in the cemetery unless in unmarked graves. I learned from the church secretary that a former pastor — Dr. Howard M. Wilson — had written a book—"The Tinkling Spring-Headwater of Freedom". I ordered this book. The story of the Scotch-Irish is told. A list is given of eight hundred persons baptized by the Rev. John Craighead—an early Scotch preacher in that area. Three of Samuel Gay's children are on this list-Elizabeth baptized in 1740-Rebecca baptized in 1741- and William baptized in 1746. This must be our Samuel Gay. I have no other record on Elizabeth but Rebecca and William are both accounted for in my records.

This book gives a map of the "Beverly Grant" that shows the 323 A. owned by Samuel Gay in 1739 — for which he paid nine pounds, ten shillings and thirteen pence. I have not been able to pinpoint his exact moves but he did leave the Tinkling Spring area for the Pasture Rivers area and from there to Anson Co. NC- which at that time, I believe extended into what later became York Co. SC.

I often wondered why these people left the Shenandoah Valley area. After reading "The Tinkling Spring" by Dr. Wilson and "The Shenandoah" by Julia Davis I found the answer. These Scotch-Irish Presbyterians were really Scotch. They were given the Irish part of the name because they left Scotland and spent some years in Ireland- from whence they came to America. They came into the Pennsylvania Colony and found the Quakers unfriendly. Thus they pushed further inland and to the Southwest. This was a sparsely settled frontier at that time. As they came into Virginia they found that the Church of England was the established church and its members were not pleased to have people who would not join their church. These Scotch-Irish were not of a mind to do that. However, the Royal Governor gave his consent to their remaining if they consented to act as protectors of the colonist against Indian attack. This did not seem to be too bad a deal as the Indians were friendly at this time. They could not establish churches but they did and were compelled to call them meetinghouses. Their ministers could not perform marriages. This had to be done by an Episcopal minister. Thus these people had to support a ministry on whose services they did not attend. This was not corrected until 1785 when Virginia had religious freedom for the first time.

The Indian terrorisms began about 1755. The French were mostly responsible for stirring up this trouble as they were paying the Indians for English scalps they brought to them. Reverend Alexander Craighead of Windy Cove Presbyterian Church, at Millboro Springs, Va., was so incensed at their being subjected to such dangers just because they wished to be free from religious persecution that he headed for Carolina. So many of his congregation went with him that there were scarcely enough people left to carry on the work of the church. He settled in Mecklenburg Co., NC and was said to be, at that time, the only Presbyterian minister between the Yadkin and Catawba Rivers. He is buried at Sugar Creek Presbyterian Church-located just north of Charlotte, NC (a few miles) on Route #29. I do not believe that Samuel Gay was a member of Windy Cove Church but I do believe that he came to Carolina in that group or about that time. I have a record of Samuel Gay and wife Jean, of Anson County, NC, selling land in the Pasture Rivers Area of Augusta Co. Va. in 1762.

The Revolutionary Pension Index (National Archives, Washington, DC) gives William Gay as a soldier with Prudence Curry as Beneficiary. York Co. SC Probate Court Records revealed the will of Charles Curry (died

1818) with wife Prudence Curry. This led to the belief that these Prudences were the same person and that she had married Charles Curry after William Gay's death. My examination of this file gave such a wealth of information that I had seventeen pages photostated for my records. Pensions were not granted immediately after the war was over. Congress passed such a law about 1830. Prudence did not apply for William Gay's pension as she thought that her remarriage disqualified her. She died in 1844. In 1852 William Newton Guy (son of Prudence and William Gay) applied for the pension of his mother. He was joined in this application by his half-sisters, Margaret and Elizabeth Curry, and his half-brother, Robert Curry. These four applicants were listed as the last surviving children of Prudence (Gay) Curry. The signed affidavits show that William Gay was the nephew of Col William Bratton, in whose Company he served-this shows, then, that Samuel's wife, Jean, was Jean Bratton before her marriage to him. The maiden name of Prudence was "Woods". On the back of the title page of a Scottish Psalter were written the marriage date of William and Prudence, the names of their five children with birth dates of each, and the date of William Gay's death.

This pension claim was granted and it amounted to six hundred and fifty dollars, covering the period from 1831 to 1844. In his application, William Newton Guy signed his name as Gay. He had to do this as his father's name was Gay on the pension records. Otherwise he is listed Guy. In his will, which was probated in Chester Co. SC in 1863, he is referred to as William N. Guy and signed as such.

The earliest Guy graves that I have been able to locate are in the Bethesda Presbyterian Church Cemetery-located east of McConnells, SC on the road to Rock Hill. These begin with William Newton Guy and his wife Eliza Lindsay. Since the early Guys were members of the Bethesda Church I believe that they are buried in unmarked graves in that area.

I have found the name, De Le Gay, in French Emigrant lists. The French Protestants were known to have migrated to Scotland. So it is possible that the original name is of French origin. An expert, in the field of Heraldry, traces the name Guy back to the name Guise in France.

The following pages will be devoted to an outline summary. Many names will have to be omitted as I do not have complete records on all descendants. Missing data can be supplied by interested persons. It is my

hope that this project will encourage more families to keep their current family records as well as those of the past.

This Indenture made the ninth day of October in the year of Our Lord, one thousand eight hundred and fifty five between Green B. Montgomery, Jr. of Chester District in the State aforesaid of the one part and Mrs. Dorcas Ingram, of the District and State aforesaid of the other part, Witnesseth; that whereas a marriage is intended shortly to be had and solomized by and between the said Green B. Montgomery and the said Dorcas Ingram; and whereas the said Dorcas Ingram is possessed of a considerable real and personal estate and chose in action, and it hath been agreed by and between the said parties that the said Dorcas Ingram and Exclusive right and title to the same property; both in possession and in action and the absolute right and title and power to dispose of said property or any part thereof either by Gift or otherwise; to such person or persons as she may from time to time or at any time thereafter think proper; and that no part of said property or the increase of proceeds thereof shall in any manner be subject to the debts, contracts or control of the said Green B. Montgomery.

Now in consideration of the said intended marriage and in Persuance of the said agreement it is hereby covenanted and agreed by and between the parties to the intended marriage (1) Firstly-that during the continuance of the said intended marriage all and singular the said estate of the said Dorcas Ingram consisting of a plantation or tract of land, whereon she new resides lying and situated in Chester District on the waters of Fishing Creek and bounded by lands of Dr. John B. Gaston, Joshua Blake, Mrs. Sarah McCullough, Mrs. Lucy Heath, containing five hundred acres more or less—three Negroes named Charles, Taby, and Gold; her undivided third part of the real and personal estate of her late husband Francis Ingram, deceased.-a note on Dr. John B. Gaston for one hundred and thirty dollars dated 9<sup>th</sup> July 1855 and due at one day; eight hundred and seventy dollars incash; Buggy, horse, stock of cattle, hogs, and sheep, crop, household and kitchen furniture-shall be remain and continue the sole and separate estate of the said intended wife, not to be subject in any manner to the debts, contracts or control of the said intended husband and the said Green B. Montgomery hereby renounces and disclaims all or any right or claim that would accrue to

him by the said intermarriage to any part or portion of the said estate; and the interest and proceeds thereof. (2) That the said Dorcas shall at any time during the coverture have the right power and privilege to make any disposition or appointment of her said estate or any part thereof by deed under her hand and seal, or by her last will and testament or otherwise without the consent of her said husband and that she shall have the power and privilege to dispose of any part of her said property, or the proceeds thereof, and invest the proceeds in any other way or manner she may think advisable. The said investments so made to be subject to all the limitations, conditions and restrictions imposed upon the property and estate herebefore dissent.

In testimony whereof and in evidence of the consent of the said Green B. Montgomery and the said Dorcas Ingram to the terms limitations and provisions of the witness whose names hereunto written, affixed their hands and seals this 9<sup>th</sup> October 1855.

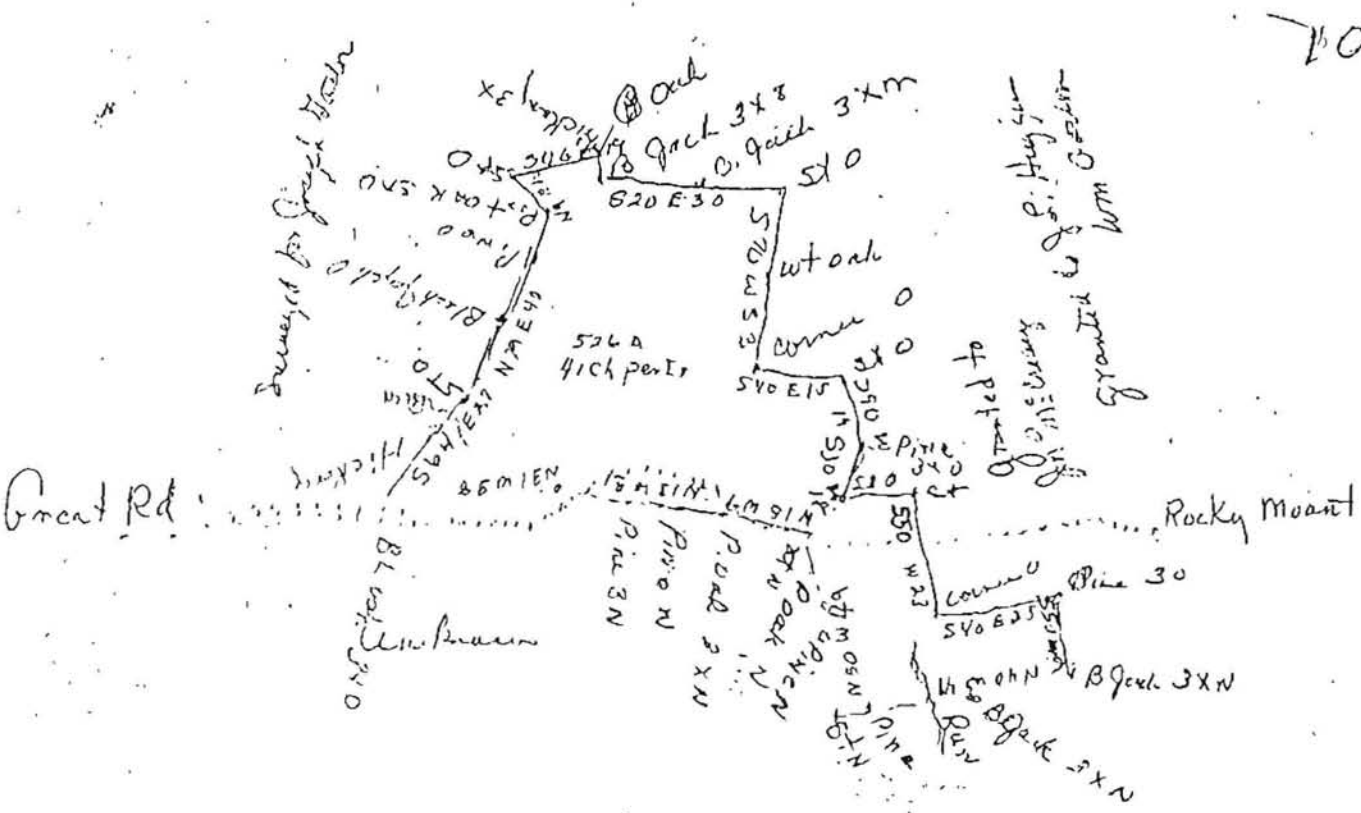

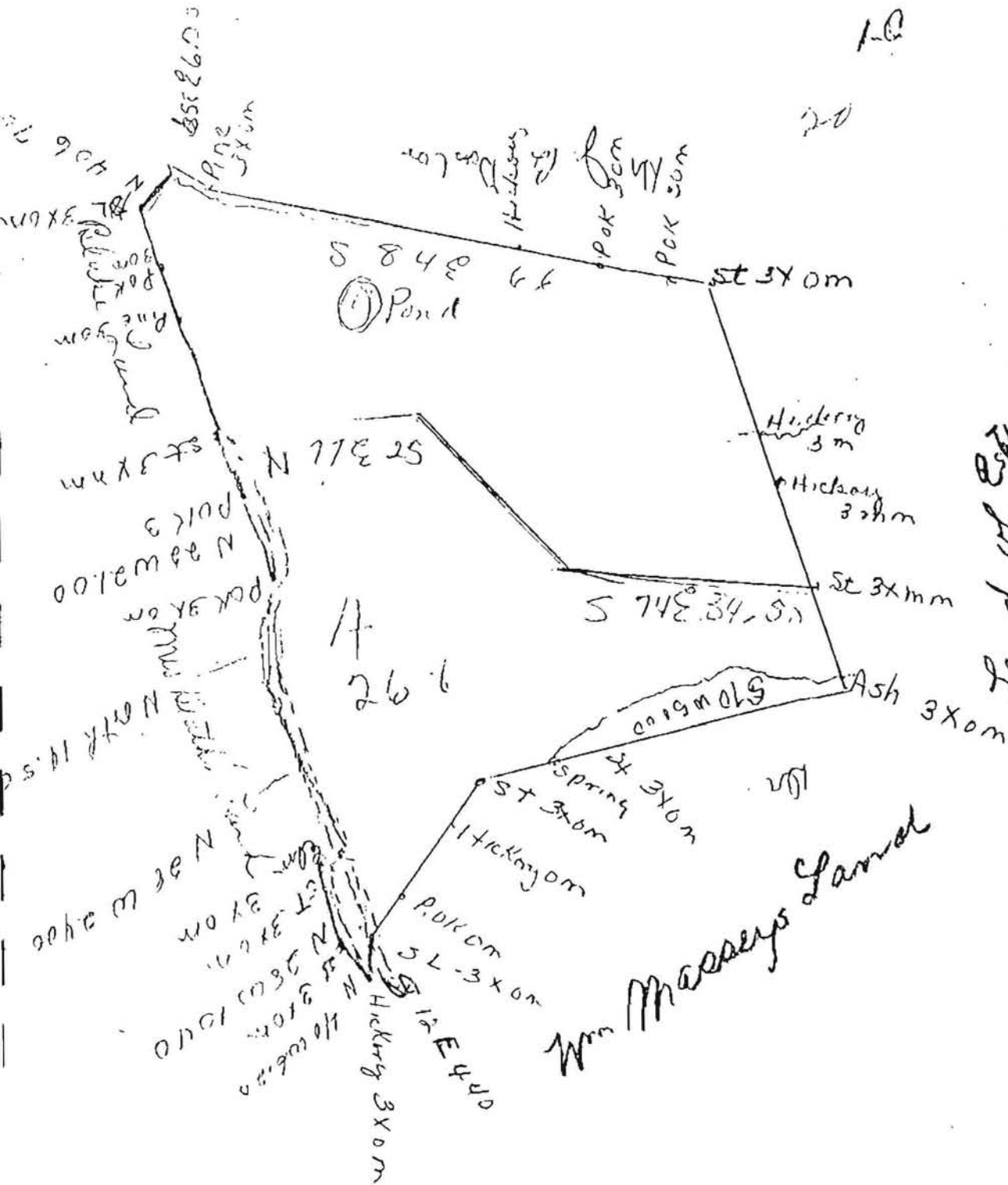

Montgomery, of the District and State aforesaid, that Dorcas Montgomery, late of the same district and state departed this life intestate On or about the tenth day of March, in the year of Our Lord, one thousand eight hundred and sixty five. Being seized and possessed at the time of her death, of a certain plantation or tract of land, containing five hundred and thirty five and one half acres more or less. Lying in Chester district, on the waters of Fishing Creek and bounded by lands of Dr. J.B. Gaston, deceased: Joshua Blake, Robert Calander and William H. Massey. The said Dorcas Montgomery left surviving her as her only next of kin and heirs at law, the following persons. Your orator, her husband: (1) Silas Gladden, her brother: (2) Ansel R. Gladden, her nephew, William Gladden, her nephew: Hillard Gladden, her nephew, Helen Dye, her niece, Amanda Howze, wife of John W. Howze, her neice. ### WILL OF JESSE GLADDEN

I, Jesse Gladden of the District of Fairfield and the State aforesaid being sick and weak of body, but of sound and deposing mind, memory and understanding, thanks be to Almighty God: and calling to mind the mortality of my body—That is ordained for all men once to die, Do make and declare this my last will and Testament in manner and form following-viz: First and

principally I recommend my Soul to God beseeching Him to forgive my sins, through the merits of Jesus Christ, and my body I bequeath to the Earth to be decently buried at the discretion of Executors hereafter named—and as touching my worldly estate which it has pleased God to bless me with—I give and bequeath in manner and form following: 1st it is my will and desire that all my just debts be duly paid and discharged. 2nd: I leave for the use of my beloved Nelly Gladden during her natural life two Negroes namely, Clara and Nut, which two Negroes I wish my son Silas Gladden to manage and see they decently support his mother, and at her death, I wish them sold for my daughters. Also I give to my wife the use in common with her son Silas of all furniture in and about my dwelling house and at her death I give it to my son Silas exclusively, except that part is hereafter conveyed to her children. 3<sup>rd</sup>: I give and bequeath to my son John Gladden one half of the tract of land on which I reside supposed to contain one hundred and fifty acres be the same more or less. Also, a Negro boy named Enoch and twenty-five dollars in him or a bed.

4<sup>th</sup>: I give and bequeath to my son Silas Gladden the other tract of land on which I live, which said part is to include my dwelling house, etc. as I expect his mother to stay with him, but never the less to be equally divided as to value. Also I give to my son Silas Gladden, a Negro boy named Doctor, and one feather bed and furniture, etc.

5<sup>th</sup>: I give to my son Jesse Gladden one third part of said land lying on each side of the Wateree Creek containing 400 acres more or less. Also a negroe woman called Aggy and one feather bed and furniture.

6<sup>th</sup>: I give to my son James Gladden one third part of my said tract of land lying both sides of the Wateree Creek—a Negro boy eight years of age, called Eric. Also of the first monies that come into the hands of my executors a—25 dollars

7<sup>th</sup>: to my son William Gladden the other 1/3 of the land along Wateree Creek and at the death of his mother, his choice of a Negro fellow named Bob or Sam and one feather bed, to my daughter Darky Gladden, a two year old filly republican. Executors—Silas-William Gladden

## WESTBROOK

The first known ancestor of the Westbrook family of Eastern Chester County, S.C., was probably James Westbrook of Prince George County, Virginia. He was born c.1660-65 either in the British Isles or in Tidewater Virginia and he died in Prince George County in 1711. From the inventory of his estate we may infer that he was a carpenter.   3. Nancy Heath.
- G. Gray Westbrook. The name "Gray" certainly bespeaks a familial relationship between the Westbrooks and the Grays of Virginia, but the exact connection is not known to this writer, who recalls reading in the Virginia Magazine of History and Biography (issue of Oct., 1922, to Oct., 1925) an article entitled "Harrison of James River," by W. G. Stanard: ". . . Capt. Gray Westbrook married Elizabeth Harrison Hobbs Woodson, first cousin of William Henry Harrison, President of the United States. . . ."

Arthur Westbrook, Sr., married second Mary Spain (Marshall) Strange, widow of Joseph Strange. She was born c.1801, daughter of Benjamin Marshall of Halifax County, N.C. (Benjamin Marshall's wife, Nancy ( -- ), married second William Neil and had one daughter, Rebecca B. Neil, who married Benjamin Jackson, Jr.)

Benjamin Marshall died in Halifax County in March, 1803, leaving his widow, Nancy, and these three children: (Howell ?)(Rowell ?) Marshall; Mary S. Marshall, wife of Arthur Westbrook, Sr.; and Elizabeth (Marshall) Sibley, wife of Edward Sibley. These children were young when their father died. Sterling Marshall was executor of the will of Benjamin Marshall. The family removed to South Carolina after Benjamin's death. Sterling Marshall died before qualifying as executor, and the estate was then administered by Jeremiah Marshall.

Benjamin (Rowell ?, Howell ?) was a brother of Nancy, mentioned above, who died in 1825. (Howell ?, Rowell ?) Marshall died in December, 1828, unmarried, in Georgia. William Neil died in 1829. We learn from an old Equity Court proceeding in Chester District, S.C., that Mary (Marshall) Westbrook was sometimes referred to as "Mary Ellis" and that Joseph Strange was sometimes called "Joseph Ellis." Is this not "strange"?

- L. Hellen Anne Westbrook. Born Mar. 27, 1840. Died Dec. 13, 1891. Married on Dec. 9, 1858, to John Wherry Westbrook, son of Samuel Gray Westbrook and his wife, Matilda Wherry, of York Dist., S.C. John Wherry Westbrook was born July 9, 1833, and died Dec. 4, 1912. For further data on this family, see below.
- M. James Alexander Westbrook. He was a magistrate in York County, S.C., and was accordingly known throughout the area as "'Squire Westbrook." Born Nov. 25, 1842. Died Jan. 26, 1922. ## James Graidison (Grandison) Leroy Huey Memoir

(Begun about 1854, about 100 pages. A summary as copied by W.B. Smith, McRae, Georgia. The original papers are owned by Mrs. James E. Patterson, 63 N, Monteray St., Mobile, Alabama.

Note by V. C. Floyd: Mrs. Patterson died the summer of 1950, age 80 years. The MEMOIRS are now in possession of a niece in Washington.

“My great grandfather, Hercules Huey; was the son of James Huey and Margaret Huey, the sister of Lord Hercules Ellis, and my great grandfather in turn married Katherine Persee, daughter of Richard Persee, a gentleman of wealth and culture. The oldest son, Alexander Huey, was trained for military life, and through the influence of his mother's family was made a Captain of a war vessel in the British navy and sent on a cruise to the East Indies where he died about 1750 on that trip and left no trace. James Huey, the second son, was my grandfather, and a short time before the Revolution landed in Charleston, S.C, and a little later settled in Waxhaw. Grandfather joined the army under General Sumter and served until the close—part time under Marion. His mother lost her first husband and married a second time a man named Abram Adams(Huey is incorrect evidently in this statement for the mother of his grandfather, Catherine Huey is buried in Waxhaw Presbyterian Church cemetery with her husband Hercules Huey, the marker being placed there so it states by their son, Hercules. “Hercules Huey/ who died/ Sept. 1775 Age/50 years./ Catherine Huey/ who died/ Nov. 16,1808/ Age 30 years./” In his will recorded in Kershaw county Hercules willed his property to his wife” Cattren” and to his “six children” and then included “my two children Abram and Margaret Adams” so evidently Catherine had married the Adams man first. (Above note of correction inserted by V.C., Floyd, 1950.), who came with her to America. Both died soon after the revolution, and are both buried at Tirzah(?). After the war closed my grandfather married Miss Polly Coffee who lived only a few months. When he married again it was to his first love, Miss Jane Walker, a daughter of John Walker and wife who was a Boyd, and who were also immigrants from Antrim County, Ireland. When John Walker settled in the Waxhaws he opened a good country store and accumulated a large stock of cattle, while his oldest son, Andrew Walker, took charge as herdsman. This Andrew, being an expert horseman, organized a company to harass the British Army during the Revolution, and at one time took thirteen prisoners. These he exchanged for his brother,



Thomas Walker, and five others who were in the Camden jail – one of the five being Andrew Jackson.

Note by V.C. Floyd: Family records show that he omitted the eldest, Elisa Boyd Huey, born Dec. 22, 1787.)

Alexander Boyd Huey, my grandfather, and his brother, Robert Davis Huey, married sisters, daughters of William McCain who married Eleanor Johnson, of an English family, whose brother's son, Richard M. Johnson, distinguished himself as an Indian fighter. With his own hand he slew the great Tecumseh, and was afterwards Vice-President of the United States under Martin Van Buren.

In 1853, Alexander Boyd Huey sold out and moved to Harris County in Georgia (the same place where Abel-Nelson went). (Note by V.C. Floyd: This is also some place and same year that Catherine Huey-Harper, first cousin of Alexander B. Huey, widow of William Harper, went to Georgia. Catherine later moved to Sumter County. Several of her brothers also migrated to Harris County about the same time.) Just after this, Robert Davis Huey moved from Monroe County to Harris County and engaged in building water mills. James A Huey was then sheriff of Harris County. Elijah C. Walker had moved to Talledega, Alabama and James G.L Huey went over there and clerked for him. He boarded with the Walker family. His uncle, Thomas W. Huey of Lancaster, S. C. got him to go into business with him and met him in Charleston where goods were bought. Dr. George Blackston Huey also went to Harris County, Georgia.

James Graidison (Grandison) Leroy-Huey was born in 1813 at Waxhaw and at the age of six weeks was baptized by Isaac Grier of Tirzah Church. His grandmother, Jane-Walker, was the second wife of James Huey. Jane Walker had carried food to her brother (Thomas-Walker) who was a prisoner at Camden during the Revolution. This was before she married. She went alone on horseback to Camden, about 43 miles, got there

just before sundown, delivered the food and returned home in the night getting home about sun-up the next morning. Her own horse gave out but she found another of a soldier, belled to let graze for feed, she put the bell on her own horse and took the other to make the trip home.

James G. L. Huey, born in 1813 was put in school at the age of six under James Thompson. He stayed with his uncle, John Walker.

In 1820 he was placed in school under Alexander J. Nisbet who was well prepared. In 1822 placed in school again under Jennings B. Kerr, a great teacher and made great progress.

“The Reverend William Blackstock, a learned and able minister of the A.R.P. church, came to reside with us in 1825 and lived in a rented house nearby and boarded with my father. He had no family having lost his wife many years before and was 70 years old and wanted to live near Tirzah of which church he was pastor. He had a good library and I spent evenings with him. He was by birth and education an Irishman, passing his collegiate life in Glasgow, Scotland and attending the divinity school near Selkirk, near Edinburgh. Came to this country in 1796.”

In 1827 William Blackstock was chosen as a missionary of the church and young Huey was taken as a helper on the trip. The darkest frontier life with the best of people who took in and fed strangers, believing in the goodness of all and asking no questions or showing suspicion. They started on the 29<sup>th</sup> of January 1828. Crossed S.C. to Newton County, Georgia, where infants were baptized and people visited but there was no church. At that time his father's oldest brother, Robert Davis Huey, had settled there. Then to Macon. They planned to go to Tallahasee but south Georgia was not settled and they were advised to turn back through Alabama. They visited people in Atauqua and Dallas county Alabama, where a large number of people from Camden and Waxhaw, S. C. had already gone. Then they went to Perry County, Alabama and stayed with some Seceder friends, the Craigs and Barrons, baptizing their children and administering sacrament. Then up to Greensboro, Tuscaloosa and Franklin and Russell counties of Alabama, where similar rites were administered. Crossed to Tennessee river through Gillas county, Tennessee, then to Maury County, Tennessee. After a week there we went to Obion near the Mississippi River and stayed there some weeks then down to Jackson near Memphis calling on people who desired ministerial aid. Then we turned eastward through Maury,

Williamson and Rutherford county, Tennessee, entered the Cherokee Nation near Chattanooga, Tennessee, crossed into Georgia by Gainsville, then to Milledgeville through Burke county where the Synod was met, and reported and ended the mission. Returned through Augusta through Chester, S. C. and back home in December, 1828.

In 1831, he taught school at the home of his uncle, Hugh Johnston McCain.

In 1832 his father sold out and moved to Harris county, Ga.. His uncle, Robert Davis Huey, had to move to Harris county from Monroe county and James Craidison (Grandison) Leroy Huey built gins and mills with him. James Alexander Huey, a cousin was sheriff of Harris County.

He then moved to Kelly Springs, Alabama, where he was engaged as a clerk for his cousin, Elizah C. Walker, and lived with the Walker Family.

In 1826, he was in the military and was an Aide to General William B. McClelland.

In 1834 his uncle, Thomas Walker Huey, of Lancaster county, S.C. asked him to go in business with him at Talledega, Alabama- met his uncle in Charleston where goods were bought and shipped to Mobile, and by wagon up the old trail from Mobile to Chattanooga (nearly 300 years old). This partnership lasted until 1857.

In 1837 in Talledega there was only one Sunday School. Robert Carey was the Methodist preacher of the church. This Presbyterian was superintendent of the Sunday School where everyone went. There he met Victoria Maclin from Greenville, Virginia, who became his wife. He was a delegate to the convention which nominated James K. Polk for President.

In 1841 he joined the Methodist church because his wife was a Methodist. A family heirloom is a very fine Bible in a Mahogany box presented to him by the Alabama Methodist conference. His wife was a member of the famous Mason family in Virginia.

In 1945? He was elected to the Alabama senate. While in the Senate he was with the party who afterwards moved the Capitol to Montgomery.

He served in the Confederate Army as a Major-General. In late life he married a second wife and moved to Perry County, Alabama where he died.

These notes were made from a record owned by Mrs. ~~James H.~~ Patterson, 63 N. Monterey St., Mobile, Alabama. Mrs. Patterson owned the original "Memoirs" which contained about a hundred pages. She died in the summer of 1950(1930?). The "Memoirs" at the time of her death were in the hands of a niece who lived in Washington, D.C.

Jonathan Wallace, son of Thomas Wallace and Margaret Lynn, was born 29 January, 1774 in Mecklenburg County, NC.

Elizabeth S. Dunlap, daughter of Robert Dunlap and his wife Mary, was born 27 December 1784 in South Carolina.

Jonathan and Elizabeth were married in 1803. Elizabeth was nineteen and Jonathan was twenty-nine years of age.

Jonathan and Elizabeth were the parents of nine children.

At age 47, Jonathan died 3 August 1821. His Letters of Administration were dated 13 October 1821 in Chester County, SC.

After the death of her husband, about 1833, Elizabeth S. Dunlap Wallace moved from Chester County, SC to Perry County in Alabama, where some of her elder children had gone before. One of the younger children whom she had brought with her was her youngest son, Jonathan David Wallace, aged about fourteen years. He often related to his grandchildren the story of the long journey from SC to Alabama in a "spring wagon". One night when they were stopping over at a vacant house along the way they were frightened by some men peering through the window, who had the appearance of a band of robbers. As the mother was alone with her small children and unprotected, she sat up all night keeping watch over the bag of money and other valuables she had with her.

Elizabeth, who died in her 68<sup>th</sup> year (24 January 1852) in Perry County, Alabama, is buried in the Bethesda Presbyterian Churchyard and the following is the inscription on the marble slab above her grave: Elizabeth S. Dunlap Wallace, who died January 24, 1852, in the 68<sup>th</sup> year of her age. Her husband, J. Wallace, died 1821 and is buried at Bethesda Church, York District, SC, age 47 years.

The parents of Jonathan are buried very near his burial place.

In the Name of God Amen

I, Valentine Bell of the country of Chester & State of South Carolina being weak in Body, but of perfect mind & memory & calling to mind the mortality of man & knowing that it is appointed for all men once to die do make, ordain, constitute & appoint this my Last Will & Testament in manner & form as follows:

Item —I give & bequeath unto my son, John Bell, one Negro girl named Sarah, which he heath now in possession on condition that if said Negro shall ever have a child to live that it shall be given to my daughter, Ratchel Bell & also I give the said John Bell one shilling sterling if required.

Item---I give & bequeath unto my son William Bell five pounds sterling.

Item---I give & bequeath unto my daughter, Elisabeth Brown, one horse to be worth eight pound sterling.

Item---I give & bequeath unto my beloved daughter, Sarah Powel, all the stock of cattle, sheep & horse now in her possession: also one Negro girl named Bais, also in her possession: also one shilling sterling to be paid out of my personal estate.

Item---I give & bequeath unto my daughter, Marcy Wilson, all the stock she heath received from me at her marriage: also one Negro girl named Eddey now in her possession & one shilling sterling.

Item---I give & bequeath unto my daughter, Nancey Boyd, all the stock she heath received from me & five pounds to be paid out of my personal estate.

Item---I give & bequeath unto my son, Zephaniah Bell, one hundred acres of land lying on the South West side of my plantation & forming lands conveyed to David Boyd & one cowe& calf & one sow and pigs & give pounds sterling.

Item---I give & bequeath unto my son, Valentine Bell, five pounds sterling.

Item---I give & bequeath unto my daughter, Fielder Atkinson, all the stock which she heath received & five pounds sterling.

Item---I give & bequeath unto my beloved wife, Marcy Bell, all the residue of my whole estate, real & personal during her natural lifetime or widowhood & at her decease of marriage to be divided between my son & daughter James & Rachel Bell in manner and form as follows: that is to say to my son, James Bell, the plantation & land thereunto belonging whereon & now loves & one Negro man named George, if my daughter, Rachel, doth receive a Negro from my son, John Bell, if not in that case she is to receive one half of the value of the said Negro George & the balance of my hole estate of stock & household furniture to be equally divided between my son & daughter James and Rachel Bell.

And lastly I constitute & appoint my trusty & beloved wife, Marcy Bell, & my son, William Bell, my sole executers of this my Last Will & Testament & do hereby revoke & disanull all and every other former will request & executers by me in any wise before named ratifying and confirming this my Last Will and Testament in witness whereof I have hereunto set my seal this sixth day of April in the year of our Lord 1799.

Adam T. Walker departed this life at his residence three miles from Chester. He was born on 7<sup>th</sup> September 1805 in Chester County. At the time of his death he was 80 years, 2 months and 12 days old.

In November 1830, he married Eliza Head, who preceded him in death by a few weeks only to that bourne from which no traveler returns. They leave five children surviving them, each of whom is the head of a family.

Dr. Samuel E. Meadow, of Fairfield County, was married on the 27<sup>th</sup> ultimo to Miss Minnie P, daughter of Reverend J D Mahon, of Crosbyville, Chester County. The ceremony was performed by Reverend R.W. Sanders of this place.
