#### Major John Pearson, Philip Pearson, and Philip Raiford Family Histories

I am a seventh generation grandson of Major John Pearson and Philip Raiford. I am therefore Philip Raiford's sixth generation ancestor. I am attempting to find a source or sources that can be of assistance to me in my attempt to find out more about my ancestors.

I know that John Pearson and Philip Raiford were soldiers or colonial militia before the revolutionary war. This information was derived from a publication named <u>A Fairfield</u> <u>Sketchbook.</u>

Is there a possibility of me being able to obtain information about my relatives who come from your area of South Carolina and England? Is there anyone in your organization that is a relative of the Pearsons that still resides in the Fairfield County region?

The next set of questions is which sons and daughters of John and PhilpPearson or their sons came to south Carolina and where in England did the family orginate. Does anyone know where in the colonies they immigrated originally and when did they arrive? Additionally, who was Philip Raiford and who was his family. I see that a Fort and a creek was named for him or some family member. I would be very interested in reaching a relative who might know why Philip Raiford Pearson left Fairfield and moved to Harrison County, Texas.

Is there any of the Pearsons and Raiford families still in the Fairfield County area? Does anyone know how to contact them? If anyone can be of assistance or can direct my inquiries to an appropriate authority, I would most certainly appreciate your assistance. **Thos. Richardson, Sr.,** born ca 1735, d. 1786, lived Bartons Branch, Broad River, Fairfield - grant of 1771. Later, in July, 1773, Thos, his sons and daughters were granted "Bounty" land on Pacolet River. Thos, granted 300 acres, Thos., Jr., William, Jane and Mary received 100 acres each. Adj. land owners on Pacolet were Robt. & Thos Pringle and John Ellison. William Kennedy, later husband of Jane/Jennet, signed memorials. My questions is: Why was this family given bounty land? They had already been in this country for some time, and our indications are that they moved from N.C. into S.C., therefore did not quallify as new immigrants. Could this possibly be for Military service of some kind, and, if so, would a Royal grant have been issued to offspring of a British soldier? Ann Richardson Davis, P.O. Box 1252, Darien, GA 31305

Seeking information on the family of **Moses Hill** (1758-1821) of the NW section of Fairfield County. I do not know where he was born but he shows up in Fairfield records from about the time of the Revolution until his death in 1821. He fought in the Revolution in Col. Richard Winn's regt., married ca.1779 **Savilla Roden/Rhoden** (1759-1844) of SW Chester Co., bought and received grants for nearly 900 acres of land on Little River and lived there for the rest of his life. When she was getting up in years, Savilla moved to Greene Co., Al, with her youngest son, **George W. Hill**, and died there in 1844. She was the daughter of **Thomas and Mary Roden** of Chester Co. who came originally from Maryland. Moses Hill was a J.P., J.Q., a land surveyor, and there are many records by his neighbors which bear his signature as witness to deeds, wills, etc.

Moses and Savilla (Roden) Hill had nine known children:

- 1. Thomas Hill, b. ca. 1780, d. 1824, Fairfield Co., m. Jemima Woodward, daughter of William Woodward and granddaughter of Thomas Woodward, the Regulator. We have lost Jemima - does anyone know where she died?
- 2. James Hill, b. 1782, d. 1854, Union Co., SC, m. in 1806 Susannah Glenn, daughter of James Glenn of VA and Chester Co, SC. This couple built the house that I live in at Carlisle (formerly named Fish Dam) and were my greatgrandparents.
- 3. Elizabeth Harrison Hill, m. in 109 Stephen Terry. They moved to what later became Atlanta, Georgia where Elizabeth d. in 1838. Stephen Terry was prominent in the early development of Marthasville (later Atlanta), Ga.
- 4. Garah Hill, m. the Rev. John Pearson of Fairfield Co. as his 2nd or 3rd wife, and there have been reports of them living in both NC and AL. They had at least one son, Moses Hill Pearson, who lived in Green Co., AL.
- 5. Moses Berry Hill, b. ca 1795, m. Mary Bowles Glenn of Union Co., and he died in 1824 in Chester Co. His widow Mary m. 2nd John Johns and she, too, wound up in AL and MS. She was the niece of Susannah Glenn above.
- 6. Littleton Hill, no dates available. Littleton made a notation in a family bible that he was the son of Moses and Savilla Hill. The handwriting is that of a young person, probably a teenager. He was reportedly buried in the same cemetery in Fairfield Co., where his father was buried, (the Yongue-Moses Hill Cem.), and there is a grave

there next to Moses with only a field stone marker.

- 7. Harriett W. Hill, b. ca 1801, d. 1857, m. Edward Pickett Mobley of Fairfield Co., and lived there the rest of her life. This couble has descendants still in Fairfield county.
- 8. George Washington Hill, b. 1803, d. 1857, in Green Coj., Al, m. Sarah A. Moore of Chester Co. SC.
- 9. Rebecca Carllisle Hill, b. 1807; d. 1842, Greene Co., AL, m. in 1828 Dr. Trezevant DeGraffenreid of Union and Fairfield Cos., moved to AL after their marriage.

Dear Friends:

I am Joseph C. Hammond age 79, and I have been in Genealogy since my youth. As a much younger man I corresponded with Mrs. Kils Drinkard, the youngest daughter of James Marshall Harrison born in 1818 in Humphreys County, Termessee, She worked with James on his memors as a young woman, when he was near blind. According to Ella James Marshall Harrison and his brother Samual M. Harrison born 1820 in Humphreys Co., Tenn., married sisters Elizabeth and Sarah Goodsin, daughters of Wills Goodrin and Mary Guest (William, Moses), Wills was the son of Crafford Goodrin and Abbey his wife. James stated that his father was Benjamin Harrison and his mother Sarah (Sally) Bradley, whose mother was a Bryant. Knowing that the Census records of South Carolina were available I looked to see where in 1790 people of these names were brought to gether. It turned out to be Fairfield County, S.C., were on the same page I found people of the Harrison, Bradley, Bryant (Briant) name were very class to gether on the same page. This took me through the 1800, 1810 and 1820 census records of Fairfield Co., S.C.. In addition I have read the history of Fairfield County, and have been examining deed records, noting the various Harrison and Marshall entries. The Bradley and Bryant families seem to be gone by 1800, but this may be due to the establishment of new boundaries of Fairfield. I might add that I need maps showing the boundaries of Fairfield for 1790, 1800, and 1810 to ascertain boundary changes. By 1820 my Benjamin Harrison had evidently migrated back through the cumberland gap and settled near Hurricane Hills in the south and of Humphreys County, Tennessee. He and his wife appear there showing births from 1775-1792. They died Sarah in 1824 and Benjamin by 1826, and the children, William, Almina, and Mary Minerva born in South Carolina, and James Marshall Harrison, Samuel M., and Betty born 1824 born in Humphreys Co., Tann., were adopted or farmed out to other families to be raised or apprenticed to trades. (I have visited Humphreys Co., Tm.) No grave markers, but field stones making it impossible to identify burial places.

For this reason I am interested in the Benjamin Harrison entries in 1810 and 1820 Census records of Fairfield County, and related deeds. I found a deed where a Benjamin Harrison purchased land around 1814 near Winnsboro. No wife mentioned. Have your deed and willrecords been published? If so what have you showing any information on people of the name Benjamin Harrison? Any one else interested in Harrison people of this period in your county?

I also noted in 1810 U.S. Census the name James Marshall; so I have followed the Marshall families as well. Since Benjamin named a son James Marshall Harrison. He usually went be the name of "Uncle Marshall". Further I have made a study of families of Harrison in Fairfield County., and have obtained information on the Reuben Harrison line and his ancestors, but be does not seem to have any Benjamin Harrisons in his line. I also followed the Burr and Cuthbert Harrison lines, and though they are in your County, they are not recorded in the Genealogies of the Burr Harrisons lines. Ferhaps the Benjamin Harrisons may have been of a separate line or kindred to one of these two groups of Harrison families.

May I ask what information you might have available on Wills and deeds to be of help for the period 1800-1850 for Fairfield County? Are they indexed? Is there any one who would check these out if they are indexed? Or is it a matter

## Hugh McMaster, J.C. Raines honored ★★★

On November 6, 1994, a government monument was dedicated to Hugh McMaster, one of the first of that name in America. He settled in Abbeville, South Carolina where he received a land grant of 100 acres. Hugh fought in the America Revolution and then returned to Ireland and married Margaret Killough. Shortly before their only son was born, Hugh set sail for America and died on board ship. He was buried at sea. Margaret and son, John, later sailed to America and settled in Winnsboro in Fairfield County, South Carolina. The monument is placed in the cemetery of Bethel Associate Reformed Presbyterian Church near his son John's grave. Hugh was a covenantor, which was a forerunner of the A.R.P. Church. Dr. Clyde McCants read from the Psalms and had prayer and Nelle McMaster Sprott told the life of Hugh McMaster at the dedication. The monument was ordered and erected by two great-great-great granddaughters: Nelle McMaster Sprott and Mary Rice McMaster.

A government marker was erected on November 20, 1994 to James Cason Raines at Mount Olivet (Wateree) Presbyterian Church near Winnsboro in Fairfield County, South Carolina. James C. Raines was killed in battle in 1864 near Richmond, Virginia. He was buried on the battlefield by two brothers, Marcus Boulware Raines and Thomas Cason Raines. Rev. Glenn Welford, minister of the church, was in charge of the service. There was special music and an honor guard of Sons of Confederate Veterans. The monument is next to his brother's grave (Marcus Boulware Raines). Marcus is the great-grandfather of Mary Rice McMaster who was responsible for erecting the monument of James Cason Raines.


