WINNSBORO BOY IS KILLED
BY A SIDE-SWIPING TRUCK

Columbia, March 29.—Columbia, city, Richland county, and state highway police were patrolling roads leading into Columbia early this morning seeking the driver of a hit-and-run truck that fatally injured Howell Jones, 18-year-old Winnsboro youth, Saturday night between 8 and 9 o'clock on the outskirts of Ridgeway, seven miles from Winnsboro. The boy's mother saw him struck down by the truck.

Young Jones was brought to the Baptist hospital immediately after the accident for emergency treatment and died at 1:33 o'clock this morning.

According to Harry Smith, stepfather of Jones, the youth was run down by the truck as he was attempting to repair a punctured automobile tire on the side of the road. Young Jones, his mother and four children, Curtis Sharpe and his mother, Mrs. Ella Sharpe, and a brother, Woodrow Sharpe, were returning to Wiansboro from Orangeburg when a tire on their automobile was punctured, Mr. Smith said.

While the boys were repairing the tire, according to Mr. Smith, the truck speeded toward them and his step-son jumped on the running board of his car in order to avoid being hit. However, Mr. Smith stated, the truck came so close to the car that Jones was crushed about the body and head. Sharpe escaped with a slight hand injury.

The injured youth was picked up unconscious twenty feet from where he was hit, and carried to a negro's house nearby until an ambulance from Winnsboro could be summoned to bring him to the Baptist hospital, witnesses said. Jones suffered a severe fracture of the skull, physicians at the hospital said.

The truck, according to police and eye-witnesses of the accident, carried a cattle body.

Rural Policeman J. M. Jones, of Fairfield county, immediately telephoned a description of the truck to Columbia and Richland county police, and highway patrolmen were notified and pressed into service to find the driver of the truck.

Witnesses told officers they believed the driver of the truck was a white man.

Prominent Attorney and Former
Legislator Dies at Home
in Winnsboro.

G. W. Ragsdale, prominent member of the local bar and outstanding and recognized in his profession throughout the state, died at his home here last Friday morning. Several months ago Mr. Ragsdale suffered a stroke of paralysis and ince that time had been declining, although until recently his friends had hopes that he would recover.

Mr. Ragsdale was born at Jenkinsville, Fairfield county, June 3, 1858. His academic education was received at Furman university, after which he prepared for his profession in the law offices of James H. Rion, and vas admitted to the bar in 1882. Shortly after this he served in the legislature for several terms, and was a member of the constitutional convention of 1895. He again served in the general assembly as senator from 1920 to 1924, during which time ne was nominated for a vacant judgeship, the contest finally resulting in the election of Judge J. K. Henry. Since that time he had devoted his ime to the practice of his profession. Throughout his career he has been a student and philosopher, more nterested in seeing that justice was lone than personal success, often caking cases which involved a principle rather than for reasons of financial reward.

His parents were Elijah Ragsdale and Nancy Ragsdale. March 16, 1887, he married Miss Inez McMeekin who survives him. From this union the following children were born: Mrs. J. H. McLaurin and Mrs. G. G. McLaurin of Dillon, W. G. Ragsdale, R. W. Ragsdale and Miss Edith Ragsdale of Winnsboro.

Funeral services were held from the home Saturday morning at 10:30 o'clock, with interment in the Methodist cemetery.

As a young man he was active as a member of the Washington light infantry, of Charleston. He was 63 years of age, and had lived in Greenville for eight years.

Mr. Strohecker was a member of the Sam-Poe lodge, No. 284, A. F.

He was twice married, his first wife having been Miss Mary Waring Lockwood prior to her marriage. She died on January 12, 1893. Surviving this marriage are two sons and two daughters: J. G. Strohecker, executive secretary of the Greenville Community Chest; W. L. Strohecker, and Mrs. George S. Hudson, of Greenville; and Mrs. C. W. Braswell, of Columbia.

His second marriage was with Miss Laura E. Gerig, of Winnsboro, who survives him.

One sister, Mrs. E. M. Lockwood, of Charleston, also survives him, as do six grandchildren.

Pending the hour of the service, the body will remain at the home, 110 Brockman avenue, Sans Souci.

Mrs. Seigler was born in Charleston but had lived in Winnsboro almost all of her life. She was reared in the home of the late Dr. B. J. Quattlebaum, her parents having died when she was young. About thirty-five years ago she was married to John W. Seigler, who preceded her to the grave. She continued to make her home here except for trips to Hickory and Badin, N.
