#### FOREWORD

This manuscript had its inception many years ago. Just as the jumbled bits of a jig-saw puzzle lying on a table are an incentive to some to work to see the finished picture, so the chance findings of bits of information about one's forefathers picked up while browsing in the stack rooms of libraries, create an urge in others to continue the search for more information, so that those earlier families may be reconstructed and the trail of their lives be followed down through the generations:

To do this it is necessary to get correct information as to where, when and how our ancestors lived, if their actions are to be understood and hold any meaning for people of today. This search is really endless and can never be finished, but just the completion of a portion, be it ever so small, brings much pleasure to the worker and gives a new meaning to history.

The worker in this type of research watches for clues and learns to follow hunches in seeking for facts. In most cases, expense and distance are formidable hurdles, and often people with this interest are able to exchange work and help each other by doing the research in their respective territories. Such has been the case in the preparation of this manuscript.

The sources of information usually referred to and accepted are Federal, State and County records, including war service records, pension records, tax records, marriage, birth and death records, census records, wills, deeds, abstracts, church and cemetery records, monument inscriptions, histories and family bibles. These records contain some errors as many have been copied from originals which are yellowed with age, the ink faded, and in many cases, the formation of letters is such that copyists mistake them. Therefore, it is impossible to keep out all errors. In this manuscript all names are copied as recorded in original sources, no corrections having been made. In many instances, further descriptive data proves the correct identity of a doubtful entry. It is assumed that burial places have remained unchanged.

Roman and Arabic numerals are used in this organization. The Roman numeral I is used only to designate the head of the first or original family whose lineage is traced as completely as possible. Roman numeral II is used only to designate the second generation or the children of the ancestor designated by Roman numeral I. All persons designated by Roman numeral II are brothers and sisters of one family. Roman numeral III is used to designate the third generation, the children of persons designated by Roman numeral II. Persons designated by Roman numeral III may be brothers and sisters in a family or first cousins to brothers and sisters in another family. Roman numeral IV is used to designate the fourth generation or the children of those designated by Roman numeral III, and so on with each descending generation. In each group so designated there will be brothers and sisters, first cousins, and cousins further removed with each succeeding generation.

The Arabic numerals are used only to designate the children in an immediate family. All known children in each family are numbered 1, 2, 3, 4, 5, etc. Because of inability to secure some birth dates children are not always numbered in chronological order. These numbers are combined with the Roman numeral of their generation, making a combination such as III-4 for each person. This designates the jourth child of a family of the third generation from the family head. To find the parent of a child so designated,—III-4,—trace backwards through III-3, III-2, III-1 to the person with the preceding Roman numeral, which will in this case, be designated as II-?-. The number between the dashes will depend on the number of children in that particular family.

To prevent printing the same material twice, a descendant of two families should trace back through the connecting marriage. A name which may appear but once in the index, may trace back to two families through the name of a grandparent or great grandparent.

Date and place of this marriage is unknown, but they came to Illinois with the family of his father-in-law, Robert McLean ar... citled very close to him on a farm that family tradition calls "Aunt Katy Aiken's farm', in Franklin County. According to the inscription on Jane's monument, "Died 1-12-1871, age 76 years, 8 months, 20 days", her birth was about April 24, 1794. James W. and Jane Aiken were both buried in Knob Prairie Cemetery, near Akin, Ill. ## DESCENDANTS OF WILLIAM AKIN I DESCENDANTS OF CATHARINE AKIN, DAUGHTER

VII-2 Catherine Akin. Born 1-20-1770 in County Antrim, Ireland. Died 12-12-1847, age 77 years, 10 months and 20 days. Buried in Knob Prairie Cemetery, near Akin, Illinois. Married James McMillen. He was born 4-8-1771 or 1777. (Last figure blurred on plot of Archer Cemetery. Their marriage was probably in South Carolina as they lived there until about 1809. This place of residence has been established by the Federal Census of 1850 which records the birth place of two of their daughters as South Carolina, 1798 and 1802. The birth dates of one daughter and the son are not established and they may have been born in Indiana. It is not known if this family came to Inand they may have been born in Indiana. It is not known if this family came to Inbut they may with the Archers, Woods, Boyd and Hogue families who came in 1806 and 07, but they were in the same community in 1809-10.

With the James McMillen family in Cibson Co., Ind. was Mrs. James McMillen, mother of James. Whether she came with her son James, or whether she was the widestablished. Records of Cibson Co., Indiana, at Princeton record the marriage of Ann to Samuel H. Wood, 10-7-1815 and the death of Mrs. James McMillin in 1817. This death is mentioned on Page 14 of the History of the Presbyterian Church of Princeton at the City Library as follows: "Mrs. Robert Archer, Mrs. Boyd, a sister of Mr. Archer, Mrs. Hogue, the mother of Mr. Samuel Hogue, and Mrs.James McMillin were called from time to eternity during that same year." The quotation follows a report of the second dispensing of Sacrament of the Lord's Supper in the fall of 1817, held in the Baptist Church, a small log building, one mile north of Princeton, Ind. Accordin 1813 and was the first person buried in Archer Cemetary. The burial place of Mrs. James McMillin is not known. The land for Archer Cemetary. Archer and it was near the old fort and the Archer home. Many records in the Courthouse at Princeton, Ind. substantiate facts about the life of the family of Catherine Akin McMillen and James McMillen. His service record in

the war of 1812 shows that he resided in Cibson County. From Photostatic copies of Muster, Pay and Receipt Rolls of Indiana Territory Volunteers or Militia of the Period of the War of 1812. Deposited in the office of the

War department of the United States Adjutant General's Office. "Vol. 3, page 498, 499, 500 and 501 contain the name James McMillin in the Muster, Pay and Receipt Rolls. P. 498 the name appears under Muster Roll of Captain William Hargrove's Company of Mounted Riflemen of the 4th Indiana Regiment Militia, called into the United States Service by John Gibson Secretary and Acting Covernor. Commanded by Colonel Robert M. Evans, from the 7th of September, 1812 until nor. Commanded by Colonel Robert M. Evans, from the 7th of September, 1812 until the 21st same instant. James McMillin is listed as a sergeant. The name appears on

Pages 500 and 501 under the Pay and Receipt Rolls." "Vol. 4, Pages 565, 566 and 567 contain the name James McMillen in Muster, Pay and Receipt Rolls. P. 565, under Muster Roll of Captain Joseph Montgomery's Company, First Regiment Indiana Militia, called into service of the United States by Cap-

tain Ephraim Gordon, from 11th August, 1812 when last mustered to 20th September, 1812, he is listed as a sergeant. Pay and Receipt Rolls are on pages 566, 567 and after the Pay Roll name is a note to the effect that he joined the Mounted Men 12 September, 1812."

These service records were received from Edna Poucher, Librarian, Indiana State Library, Indianapolis.

Many records which help to reconstruct the life of the James and Catherine McMillen family are stored away in the Courthouse at Princeton but many are in a bad condition. In the Recorder's office, Deed Book A, Page 44, is the record stating James McMillin bought from Robert Evans, Agent for Gibson County 4-1-1814, "im lot" . (meaning inside lot) No. 63 containing about one half acre, and on the same date, page 67, records the purchase of "im lot" No. 25. On Nov. 21st, 1814, James McMillen died. As he was a comparatively young man, it is possible he was injured in service. The Court records show the appointment of his widow Catherine as Administrator and Guardian of the children, list the inventory of his estate, and the sale and settlement. Considerable livestock and household goods were listed in the inventory also a box of books which was not too common among the settlers at that time. No record was found of the purchase of the eighty acre farm where they lived. It was the West 1/2 of the N. W. 1/4 Section 3. Tp 2-S, range 10-W, 2nd P.M., Gibson Co. A certificate by an attorney from the rocords of the General Land Office, Washington, D. C. states this plot of land was originally claimed from the Land Office at Vincennes, Indiana, August 18, 1819 and September 28, 1822 with cash certificate No. 1585 by John Whitsett. The Probate Court Civil Order Book C, page 247, Feb. term, 1826, records a debt of Catherine McMillin to John Whitsett, continued until next term of court. Although no record of the purchase was found before James McMillin died, this item was probably a final payment by Catherine.

Later records show when Catharine McMillen sold the property of her deceased husband. Most of the deeds were dated 1826 but some not recorded until 1831. The deed for City lot No. 63, 9-18-1826 is recorded in Deed Record Book D pages 125 and 6, and the deed for lot No. 25 is recorded the same date on page 127. On the original plot of 1814, Lot 63 was one block north and one block east from the Northeast corner of the Courthouse square. The residence of Robert Archer Woods stands on Lot 25, and the research work on this McMillen family completed a link in the abstract for this lot which had one transaction missing. Deed Book D Pages 72 and 73 records the deed for the farm, legal description given above, dated 10-6-1826. The deed was signed by Catharine McMillin and heirs, but as in other cases, some of the heirs came into Court and signed at different times. Such signatures often furnished evidence of relationships. The signatures on this deed were Catherine McMillin, James McMillin and wife, Elizabeth, James Akin and Sarah Ann McMillin Akin, Hiram Corn and wife Margaret Jane McMillin Corn and Henry Redburn and wife, Katharine A. Mc-Millin Redburn, proving four married children of James and Catharine (Akin) Mc-Millin in 1828.

Other items in these Court Records are interesting and helpful. Probate Court Record Book C in 1822 or thereabout, describes the building of a state road from Evansville to Terre Haute, Ind. as follows: "Commencing at the North end of Main Street in Princeton, thence N. 3 E. 320 poles to a stake near the Widow McMillin's field,

thence ... to a sugar marked 2 mi. from Princeton, then on to Patoca Bridge"-apother check on the location of the McMillen farm. In the same Record Book, page 103, an entry is made that James McMillin, James Akin, and James Whitsett promise to pay a five dollar fine for a misdemeanor, and the money for the fine was to go to the seminary of learning in Gibson County, 1823. This proves that James Akin was in Gibson County at least two years before he married his cousin Sarah Ann,-the sister of James McMillin Jr.-in 1825. According to these records and family tradition the McMillin family broke up as a unit in Gibson County. In 1831 or 32 the widow, Catharine McMillen went with her daughter Margaret Jane and her husband Hiram Corn to Franklin County, Illinois, and there joined a group of relatives, some native of Ireland, who had settled there earlier. This change of residence from Indiana to Illinois has been established by data from the 1850 Federal Census. The first three children in the Hiram Corn family were born in Indiana and the fourth child in Illinois. Just where Catharine McMillin lived between 1826 and 1840 is not certain as she had two married daughters, a sister and a brother living in Franklin County, but the 1840 Census names her as a member of the Hiram Corn family in that county. She is buried in Knob Prairie Cemetery near the grave of her son-in-law Hiram Corn. The inscription on her monument which was standing in 1940 was "Catharine McMillin, died Dec. 12, 1847, age 77 years, 10 mos.," thus establishing the birth date, Jan. 20, 1770.

III-1 Sarah Ann McMillin. Born between 1798 and 1802 in So. Carolina. In an article about her husband in a Franklin County History, her death is given as 1860, age 62 years. She married James T. Aikin (Akin) 11-19-1825, marriage recorded at Princeton, Ind. He was a first cousin of Sarah Ann's, and the son of James Akin Sr. II-4 and Catharine McLean III-1 Akin. He was probably born in No. Carolina, date unknown. His parents went from North Carolina to Greene Co., Ohio, and after a year or two there they went to Princeton, Ind. This couple located in Frank-lin County, Illinois, where they had many relatives. James entered a farm in Eastern Township. The above mentioned Franklin County, Ill. History states he died about 1835, leaving one son, the only survivor of six children. For the rest of this line sce Descendants of James Akin II-4, "James T. Akin III-11".

III-2 Margaret Jane McMillin. Born July 17 or 18, 1806, in So. Carolina. Died 2-16-1892. Buried in Oak Hill Cemetery Taylorville, Ill. She came to Princeton, Indiana, with her parents about 1809 and there married Hiram Corn, July 8 or 9, 1824. Marriage is recorded in Gibson County Records at Princeton. Hiram Corn was born 8-23-1787 in Kentucky. See Corn History, Part II, Allied Families. He served in the war of 1812 as a private under Captain Lewis in the County Militia, 13th Regiment, was wounded in the shoulder by an Indian's arrow, and was a prisoner of war at Ft. Meigs. He received eighty acres of land at two different times under Bounty Land Acts. Land Certificate Nos. were 1616 and 8261, one issued from the Shawneetown Land Office and from Warsaw, Mo. Office. The land was claimed after the Acts of 1850 and 1855. One of these tracts was in Hamilton County, Ill. and the other in Morgan County, Illinois.

Hiram Corn and his wife Margaret Jane McMillin Corn moved from Gibson Co., Indiana to Franklin Co., Illinois about 1831. Birth dates of children named in the 1850 Federal Census establish this move. County records of Franklin County at Benton, Illinois, show transfers of land by Hiram and his wife in 1851 and 53 and about 1854 they moved to Morgan Co., Illinois and are listed in the State census of 1855. After a few years, he and part of the family returned to Franklin Co. where he died 4-10-1863. He is buried in Knob Prairie Cemetery, near Akin, Illinois and his monument was repaired in 1949. Hiram and his wife who was known as Peggy, had twelve children. The names and dates of birth are taken from his family Bible which is now in possession of Mrs Gladys Corn Becker, Springfield, Illinois.

Elizabeth Frances Corn died 11-14-1898 and is buried at Harvel, Illinois.

C. The 1850 Federal Census states he was born in Georgia. Both could be correct. He was about 7 years old when he came to Illinois with his parents, Nancy Akin II-3 McLean and Robert McLean III-7. On Oct. 4, 1829, he married Lydia Smith. Federal Census of 1850 gives her birth as 1814, No. Car. They built their log cabin about three quarters of a mile northeast of Akin, Ill. and the first two children were born there. Then he built a double log cabin on the hill or high ground northwest of Akin, into which he moved. After this he was called High Ground Ake, to distinguish him from Aiken McLean who lived on the low ground close to Knob Hill. Information about the home is from the address of Dr. Hall referred to above, which also gives the date of his death as 1883. His wife died a few years later. Both are buried in Knob Hill Cemetery, near Akin, Ill. The names and dates of children and grandchildren are taken from Dr. Hall's address which was delivered Aug. 29-1912. Names marked with \* were deceased at the time. In some cases the 1850 Federal Census has been used to compute the year of birth.

### DESCENDANTS OF NANCY AKIN, DAUGHTER OF WILLIAM AKIN I

II-3 Nancy Akin. Born in 1771, County Antrim, Ireland. The inscription on her monument reads "Died 2-5-1844, age 73". She lived first in Pennsylvania, then in South Carolina. Records in Guilford Co., North Carolina, record her marriage 5-6-1791 to Robert McLean. According to information furnished by a descendant of the McLean family, this Robert McLean was the 7th child of John McLean, Jr., and Jane Marshall, who married in 1751 and went to No. Car. about 1760. Robert was probably born there as his birth date was 1762. His grandfather John McLean came to America about 1737. See John McLean Family, PART II, Allied Families. Nancy Akin McLean and her husband Robert McLean, five children, and James Akin, husband of their daughter Jane, arrived in Franklin County, Illinois, in 1816. It was a long trek from North Carolina, and they had stopped and lived for a while in Ohio, also in Gibson Co., Indiana. In the latter County, had been established the home of Catharine Akin (II-2) McMillen, a sister of Nancy Akin McLean. Such stop-overs were often prolonged visits with members of the family that had preceded them and had not been scen for some time.

Nancy's husband, Robert McLean, was the first man to settle on Knob Prairie, Franklin Co., Ill. He built his cabin about one-half mile cast of where the village of Akin now stands. The nearest white man was about eight miles distant, in Cave Township, where the Jordan Brothers, William and John Browning, Joseph Estes and William Barbrey had settled and built Jordan's Fort. This fort was occupied at intervals until 1817. The nearest neighbors in other directions were at Knight's Prairie, 12 miles distant where the Moore and Hall families had settled. The Dale and Shirley Families had settled at the edge of Hall Prairie, six miles northeast. In 1818, Robert McLean's brother-in-law, James Akin (II-4) arrived with his family and settled in Eastern Township on Knob Hill, Franklin Co. Soon, other relatives came. James Akin (II-4) became known as "Knobby Jim", to distinguish him from his nephew James Akin, the son-inlaw of Nancy and Robert McLean. (Data from the address by Dr. Andy Hall at the Aiken-McLean Reunion at Knob Prairie Church, Aug. 29, 1912.)

Nancy Akin McLean and her husband Robert McLean were buried in Knob Prairie . Cemetery, near Akin, Ill. Monuments were in fairly good condition in 1940.

"Dr. Andy Hall, Outstanding U. S. Doctor, To Be Honored at State Medical Meet."

"Dr. Andy Hall of Mt. Vernon, chosen last December as the outstanding doctor of the nation for 1949, will be a special guest of honor at the 110th annual convention of the Illinois State Medical society which opens here Tuesday, for three days. He also will be a guest of the Sangamon County Medical society, which will convene at the same time.

"Dr Andy", as he is affectionately known by his neighbors, was born Jan. 8, 1865, on a farm in Hamilton County, the eighth of nine children of Lt. Col. and Mrs Hiram Hall. She was the former Miss Julia McLean.

The Hall family, descendants of Lyman Hall, whose name was third on the Declaration of Independence, came to Illinois from Georgia in the early 1800's.

Dr. Hall got his first few years of schooling in a one room log school house, whose teachers he still remembers clearly after nearly eighty years. One of them, Miss Betty Turntine, found him drawing a horse on his slate in spelling class one day and punished him with her favorite four foot switch, he recalls. "Today", Dr. Hall said, "they hire people to teach the kids to draw". Dr. Hall got his medical education at Northwestern University. He was graduated from Northwestern in 1890 and immediately "hung out his shingle" at Mt. Vernon, then a town of 4000. Rent on his first office, consisting of two upstairs rooms in a down town building, cost him \$5.00 a month, he remembers.

By 1892 he made sufficient progress to feel justified in taking a wife, and Jan. 1, 1892, married Miss Anna Laura Glazebrook, a teacher. He has always been an active member of the First Baptist Church in Mt. Vernon. In 1946 the Mt. Vernon Chamber of Commerce voted him its annual civic award "for outstanding and distinguished community service". When his selection as outstanding general practicioner for the state in 1949 was announced by the Illinois State Medical Society, the popularity of the choice was demonstrated by a flood of letters, telegrams, and telephone calls, as old patients congratulated him on the honor. Dr. Hall's contributions to community welfare were exemplified by his service as Mayor of Mt. Vernon for a term and as head of the local school board for eight years. However, his most unusual service to the town occurred in 1913. Looking from his office window one day, he saw a hold-up man back out of a bank across the street and head for a quick getaway. "Dr. Andy" seized a rifle in his office, cranked up his gas buggy and pursued the robber to the outskirts of the town, where he disarmed him and held him until the sheriff arrived.

"Dr. Andy" was the first in his town to sign up for the Spanish-American War. He was regimental surgeon for nearly a year, fighting yellow fever and other diseases in the Cuban tropics. He also served as an army doctor in the Philippines during the Insurrection and World War I. He saw only stateside service in World War I, but he recalls being ambushed on several occasions while serving in the Philippines.


Back home after 1919, Dr. Hall rebuilt his practice and organized the Fifty Year Medical Club in Illinois. Other states since have copied the organization. Dr. Hall practiced medicine in Mt. Vernon for nearly 60 years. The medical profession was a rugged test of character and physique in the 90's. He had a horse at first and later a horse and buggy, but he soon learned the quickest way to reach many country patients was to swing aboard a train and ride to a point nearest the patient's home, then cut across the open country to the home. He remembers on one occasion when he was unable to get transportation he walked nine miles on a winter day to perform a mastoid operation. After the patient was comforted and put to sleep, he walked nine miles back to town. Dr. Hall's practice has always been a typical combination of obstetrics, medicine and surgery. He estimates he averaged 70 deliveries a year over half a century, bringing into the world 3500 children.

His pre-eminence as a physician was further attested when he was appointed director of the department of public health of Illinois in 1929. He served four years. During that time he organized crusades against smallpox, diptheria, trachoma, typhoid and dysentery in the state. The diseases were cut down to a great extent. Almost single-handed he maneuvered through the State Legislature a bill to require physicians to instill silver nitrate into the eyes of new born babies to prevent blindness due to gonorrhea. When World War II drained the nation of its young doctors, Dr. Hall, then nearing eighty, felt it was his duty to continue active practice although he had considered retiring. His acceptance of that responsibility, was in the opinion of his fellow townsmen, the crowning achievement of his long career.

# DESCENDANTS OF JAMES AKIN, SON OF WILLIAM AKIN I

II-4 James Akin. Born 1-9-1775 or 76, on passage to America. This date has been computed from the inscription on his monument which reads "James Akin Sr., 80 yrs. 9 mos. 22 days. Died 10-31-1855". The last figure was indistinct and may have been 6. He was known in Illinois as "Knobby Jim" or "Knob Jimmy". He probably lived in Pennsylvania while his father was in Revolutionary service, then went with his parents to South Carolina, Fairfield District. Like his sister Nancy, he was married in Guilford County, North Carolina (record in Guilford County Courthouse), and he also married into the same McLean family which had settled there near another family by the name of William Akin. He married Catharine McLean, 12-12-1800, a cousin of Robert McLean (III-7), who had married his sister Nancy Akin (II-3). The inscription on her monument reads "Catharine, wife of James Akin, married 12-11-1800, died 9-8-1853, age 76 years". They may have lived in North Carolina as did his sister Nancy, until they started on their trek to Illinois. This family stopped a year or more in Greene County, Ohio, and then again for a few years in Gibson Co., Indiana. They probably left Carolina about 1810 or 1811 and reached Gibson County by 1814. According to the records of Gibson County, James McMillen, husband of his sister Catharine Akin (II-2) McMillen, died in 1814. Records of the inventory and sale of the estate of James McMillen, show that James Akin bought many articles.

The names of the children of James and Catharine Akin, but not the birth dates, were given in the family sketch on the printed invitation to a family reunion at Akin, III. 8-31-1911. In 1817 a child was buried in the Archer Cemetery near Princeton, Gibis son Co., Indiana, on the same lot with James McMillen who died in 1814. The inscription on her tombstone, still legible in 1945, read "Jane Akin, born 1-2-1807, died 8-7-1819". She was probably a child of this family and was buried beside her uncle, James McMillen.

Sketches of family history state that James Akin, known as Knobby Jim, arrived in Franklin Co., Ill. to make his home, in 1818. If correct, the child mentioned above was probably left with the relatives in Gibson Co., Ind.

James Akin and wife, Catharine McLean (III-1) Akin, are both buried in Knob Prairie Cemetery, near Akin, Illinois, Operation R



In 1838 he was elected Assessor of the county and Aug. 28th 1838, he and Mr. Ewing entered the land on which the town of Benton, Franklin Co. stands. Williamson County was formed and cut off from Franklin in 1839 and the legislature located the county seat upon the land of Akin and Ewing who donated to the County Commissioners 22 acres for a town site. #### CORN FAMILY

Authentic records of the Corn family date back to over a hundred years before the Revolution, as a will of William Corn, dated July 18, 1650, is listed in Volume I of Virginia Colonial Abstracts. The Archives of New Jersey and Pennsylvania also have early records of this family name, the variant spelling including Corn, Corne, Corns, Cornes, Carn, Carnes, the German version Kern and others. Many sons of these names have authentic Revolutionary service records. During the period of the Revolution and immediately following, many of the Corn families joined the great migration to the Western Frontiers, some settling in that section of Western Virginia that later became the state of Kentucky.

An attempt has been made to find and herein record pertinent data which will aid in establishing relationships and locale of these early Kentucky settlers whose descendants are now so widely scattered.

The Kentucky Historical Magazine in the first issue for 1946, published an excellent article on The Corn Family, by Col. James F. Corn of Cleveland, Tenn. This article presents a definite outline of the family of "Old George Corn" who died in 1801 in Mercer County, Ky. where he lived so many years. That he was a doughty pioneer is evidenced by the record of the many law suits he filed in the Mercer County Court before 1800.

Another family of Corns which settled within fifty miles of "Old George" in a section that later became Washington County, was Edward E. Corn, wife Phoebe, children and grandchildren as early as 1785. The signatures of Edward and Andrew follow that of Ebenezer, a son of "Old George" on a document petitioning the formation of a new county in that year. That Edward E. Corn was also "old" is substantiated by his statement which is with the marriage bonds of Catharine Corn and William Hazeltine, that she is over 21 years old and is his grand daughter) The date given is June 24, 1788 and all the papers are filed at the Courthouse at Harrodsburg, Mercer Co., Ky. Furthermore, the Mercer County Court Feb. 22nd, 1791, exempted Edward Corn from County levies on account of "age and infirmities". He died in 1795, and in Washington Co. Minute Book B, is record of the naming of Phoebe Corn as Administrator, who with Nathan Davis and William Yates as security, gave bond in the penalty of 100 pounds. In December 1798, the inventory was returned and approved.

Although many interlocking indications are found, no definite proof of relationship between the two "OLD" Kentucky pioneers has been forthcoming.

Results of the research to ascertain a definite location from which the Edward E. Corn group emigrated, disclose that the records of Hampshire Co. Virginia, now West Virginia, furnish the most likely clue. Both Edward E. Corn and Andrew Corn are named in the Court records at Romney, involving a 3-life lease of 307 acres on Patterson's Creek. (Section known as The Northern Neck, Part of Lord Fairfax Tract, in Colonial Times). Furthermore the Journal of the House of Burgesses of Virginia, 1766-69, Vol. II Page 294, Session Nov. 25, 1769, Tenth Year of the Reign of George III, lists claims of David Corn and Edward Corn Jr., for scout duty along the Western Frontier, Hampshire Militia, and Andrew Corn for provisions furnished. This may have been the background of the Edward E. Corn group of Washington Co. Ken. as it is not far from that section of the Frontier from which the family of "Old George Corn" came.

Among the tax-payers listed for Washington County, Ken. the names of Andrew, David,

John, William and Edward appear from 1791 to 1808, and the following early marriages were copied from the Court house records at Springfield:

In the period from 1810 to 1830 there was a mass movement of Kentucky settlers into Indiana, Illinois and Missouri, and many Corn families again sought "Green Pastures". Many of the family of "Old George" settled in DuBois Co., Indiana. Mrs. Erra Davidson, 287 Madison St., Twin Falls, Idaho, a descendant, has much tabulated data concerning this group. For information regarding a group of descendants of Edward E. Corn who settled in Pike Co., Indiana, address Miss Julie E. Tulpin, 1136 North Ninth St., Springfield, Illinois.

By 1820 the Corns from Washington Co., Ken. had scattered in Kentucky or elsewhere, as the Federal Census for 1820 of that County does not list any family head by that name. However, the 1812 War Service record of Hiram Corn, indicated a search in Shelby County, and the 1810 Federal Census of Shelby listed three Corn families consecutively, viz., John, Edward and Andrew.

John appears to have a family of four, but the record is illegible. Nothing more has been learned of this family.

Edward is listed as a family head of five, which includes 1 girl and 2 boys all under five years of age. Edward died before 1824 or during that year, as the Mercer County Court awarded custody of his two minor sons, 17 and 19, to Asa Corn. (See Deed Book 13, page 118, Harrodsburg, Ken.)

Andrew is listed as over 45, wife over 45, 1 girl and 1 boy under 10, 2 boys and 1 girl under 16, 2 boys and 1 girl between 18 and 26. This appears to be the family background of Hiram, James, Asa, Charles, Sarah and Catharine and possibly other brothers and sisters.

The tax records of Shelby County list Andrew, Hiram, James, Asa and Charles from about 1801 to 1824, paying personal or land taxes. Three tracts of land, all located on Crooked Creek were paid on. In 1824, the formation of the new County of Spencer included this section,—Mt. Eden District—and Andrew's tax paying record continues through 1826. That he died about this time is indicated by the fact that Charles certified his two sisters were over 21 at the time of their marriages in 1827. (Bonds are at Taylorsville, Spencer County, Kentucky.)

Since definite proof is lacking, the following outline naming Andrew Corn as the father of Hiram, James, Asa, Charles, Sarah and Catharine is only an assumption based upon the description of the family given in the 1810 Federal Census of Shelby County, other Court records of Shelby and Spencer Counties and the association of names and traditions. It is

probable there were other children besides the above named. Definite data relative to the known members of the family follows with the assumption that Andrew Corn was the father; no trace of the mother has been found at the time of publication.

- I- Andrew Corn. Taxpayer in Shelby and Spencer Counties, Ken. Owned a tract of 104 acres on Crooked Creek. No trace found after 1826.

State Historical Library. His death occurred between 1838, the date of his will, and 1842 when the first settlement was filed. Will Book 12, Shelby Co.)

II-2 John McLean, Jr. Born in Ireland, 1724, and came with his father to Pennsylvania in 1737. He married Jane Marshall (supposedly a sister of Nancy Marshall) in 1751. Between 1760 and 1765 he went to North Carolina and secured a tract of land on the waters of Alamanse Creek. He built first a log cabin on the slope of a hill above a spring in which he lived until he completed a new house for a permanent home. The new house was completed before 1767.

An article dated March 17, 1898, and signed by W. P. McLean, was loaned for use in this manuscript, in order that the description of the house, which follows, would be given by one of the family who was familiar with it.

#### "AN HISTORIC OLD HOUSE"

"The present seems to be an age of reminiscence, and of digging up old family histories and bringing to light old and curious family relics. It is with this reminiscent feeling that the writer undertakes to give a brief history of an old house in Guilford County.

"About the year 1750, at the time of what is known as the Scottish-Irish movement, John McLean, a native of the County of Ulster, Ireland, moved from the colony of Pennsylvania, to secure for himself and his posterity a home in the wilds of North Carolina. He entered a large tract of land on the waters of Alamanse Creek in what was then Orange but now Guilford County. Within sight of this historic stream he built his house and it is more of this house than of those who occupied it, that I wish to write. The exact date of its erection is not known, but we are certain that it was built before the year 1767. It is now in possession of the fifth generation of McLeans descended in the direct line from the original owner and is now, and has been, during all these years, occupied as a dwelling. We think that it is the oldest inhabited house in Guilford County. The house is almost a quadrangle, three sides built of yellow poplar logs, sawed eight or ten inches square, pinned together at the corners and placed on a solid rock foundation. The huge construction was called the frame and it was then weather-boarded and scaled, and was originally painted red. It fronts to the East and has a porch running along both the east and the west sides. The south end is built entirely of rocks, and originally contained a fire-place eleven feet wide and so high that a man six feet tall could stand under the mantle. The front door, a heavy but rather handsome affair, was made in two parts, an upper and a lower. All the lumber used was gotten out and prepared by hand, and shows some very fine artistic workmanship. When first built and for a long time, the entire house was in one room and heated by this immense fire-place. Marshal McLean, the second propietor, divided it into two rooms and built a chimney at the North end. John Marshall McLean, the third proprietor, built an ell against the front, but without making any changes in the exterior appearance of the house. Walter H. McLean, the present proprietor, has filled in this large fireplace, has extended a partition in the opposite direction and thus made two comfortable rooms, with a fireplace in each one, all from this one fireplace. Notwithstanding all these changes, the outside appearance of the old house is the same today that it was when the Liberty Bell sounded in 1776.

"This quaint old house has been the home of the same family under two local and three national governments. Under its broad low roof has slept soldiers of five wars. It has the

#### McLEAN FAMILY

The history of this McLean family is probably of more importance to the Akin descendants than that of any other allied family, as it has been so closely associated with the Akin family for many generations. Records show that the two families were inter-marrying in the 1790's in the Carolinas and may have before that time. Two of the four children of William Akin married into the family of John McLean between 1790 and 1800, making all the descendants of these two Akin children lineal descendants of both families. Numerous other marriages between first cousins have occurred in these families in following generations. Because of such double relationships the two families have had much in common, several of them making the trek to Illinois together about 1816-1818. One hundred years later, descendants of these families erected a granite marker at Akin, Illinois, commemorating this venture of their pioneering forefathers.

The data for the history of the McLean family has been handed down from generation to generation, and was given for this manuscript by Miss Jessie Roberta McLean, retired member of the faculty of The Woman's College of the University of North Carolina, Greensboro, N. C., now living at No. 927 Carr Street, Greensboro. Newspaper clippings and copies of old manuscripts were loaned so that copies and quotations could be made. Some data has been secured from state and county records and from local county histories.

The following is quoted from the Greenesboro, N. C., Daily News, Sunday, Oct. 30, 1932.

"The McLean ancestors emigrated from the Western shores of Scotland to the County of Tyrone in the province of Ulster, Ireland, a few years after King James VI of Scotland became, by inheritance, King James I of England. For several generations they lived in Ireland, and that is why they are called Scotch-Irish. There, John McLean was born about 1690 and there he married in 1715. In 1737 he emigrated to the colony of Pennsylvania and located on the Schuykill River, 20 miles above Philadelphia. There, he lived and died."

The name of the wife of John McLean mentioned in the above quotation, and designated hereafter as John McLean I, is unknown, but the names of his six children who came with him from Ireland in 1737, were Eleanor, who was married in Ireland, John, Joseph, Martha, Margaret and Isabelle.

I. John McLean. Born in Ireland about 1690, married in Ireland 1715, came to the colony of Pennsylvania 1737 and died there.

honor of sheltering Col. William Washington in the spring of 1781 while his troops reposed under the tall graceful poplars in the yard. There are those who can trace their ancestry back to this old house, now known to be living in the states of New Jersey, Maryland, Virginia, North Carolina, South Carolina, Georgia, Texas, Tennessee, Illinois, Missouri, Kansas, the Dakotas and Washington, and many have been lost sight of and are, perhaps, living in other states. They have spanned the Continent and among them are found lawyers, physicians, teachers, ministers, merchants, farmers, mechanics and artisans. Such is the history, briefly told, of the old house. The companions of its early days are all gone, but the old stone doorsteps upon which brave men trode, when with knapsack and rifle they left home at their country's call to endure all hardships of a soldier's life are the same now as then. The same stories are in a large old chimney around which sat mothers, wives and daughters, who, with deft fingers, made wonderful fabrics of flax, wool and cotton, for the anxiously waited loved ones far away. The beautiful waters of the Alamanse sing the same song as they ripple over the same stones now as then. All else is changed, even the sturdy oaks and tall poplars have decayed and died. Generations have come and gone. Some have sought homes in the far west and long since mingled their ashes with the dust of the prairie. Others have been laid to rest in the Alamanse Churchyard and the same Alamanse Creek which sang their lullaby when they lay in their cradles now sings their requiem as it rushes past their graves. Still the old house stands as of yore extending its hospitality to all who may come. Another and a younger generation now roam over the old house, now peering into nooks and crannies and wonder what they were for, exploring the mysteries of the old garret and bringing to light the old swords, pistols and reap hooks, implements of war and peace, little dreaming of the hardships endured and the sacrafices made by the owners of those implements to secure the liberty and freedom they now enjoy."

The Greensboro, N. C. Daily News, October 30, 1932, carried two photographs with accompanying material describing the unveiling of MCLEAN HOUSE MARKER. This huge 14,000 pound boulder is on Highway No. 10 at Sedalia, eight miles east of Greensboro, N. C. This marker was erected by Guilford Battle Chapter, Daughters of the American Revolution, and the descendants of John and Jane Marshall McLean. At the unveiling of the marker, a message was read from Mrs. Nellie Baker Ingraham, Pasadena, California, and thanks extended to her and to Mrs. Charles Baker, also of Pasadena (McLean descendants) for making possible the fund for the marker. They are descendants of Anne McLean Donnell, grand-daughter of John McLean who built the above described house, and her husband George Donnell, who went to Greenville, Illinois in 1819. The bronze tablet on the boulder carries the following inscription:

"McLean House. One half-mile south of this marker stands the home built by John McLean and his wife Jane Marshall McLean, before 1767. Col. William Washington spent some time in this house in the spring of 1781. It has been the home of five successive generations of the McLean family, members of which have served in six wars. Erected by Guilford Battle Chapter, Daughters of the American Revolution and descendants of John and Jane Marshall McLean. 1932."

Another quotation of interest concerning McLean House is taken from this same paper.

"Interest centers about this house from another angle. Shortly before the Battle of Guilford Courthouse, while Lord Cornwallis and his army were encamped in this neighborhood, his cavalry and detached parties were constantly pillaging and plundering the houses of the community. They were especially destructive to the property of all Whigs. A squad of these British soldiers came here and pillaged this home and premises, carrying all they could use for man and beast and destroying much that they could not take with them. Tradition says that Lord Cornwallis himself was a member of the raiding party that plundered this home, and that some of his soldiers camped here and were very destructive to property, Marshall C. Stewart, a great-great grand-son of John McLean (1724-1807) now has in his possession a soap trough, such as was used in the olden times for making lye soap, which has been handed down to him with the tradition that Cornwallis and his men used the soap from this trough."

The same issue of the Greensboro Daily News states that McLean House was sold by Walter H. McLean, in 1908 to Palmer Memorial Institute, after being held by the McLean family 148 years.

John McLean II-2, died in North Carolina in 1807.
