

#### FOREWORD

I truly hope the information presented here will prove of interest to many members of the Milling Family. The collection of data has been a fascinating pastime for me. My interest in my forebears began when I was a child due to the fact that my father owned the Robert Milling Family Bible containing the family record of births, marriages, and deaths. The record was begun by Robert milling and continued by his oldest son, Hugh Alexander Milling, my grandfather. Of course, we also had my father's Bible with its record. I was never able to add to this information until the first summer after 1 was married when 1 accompanied my husband who was traveling the State. Since we passed near the place in Fairfield County where I lived as a child under ten years of age, I suggested that we visit Salem Presbyterian Church which our family had attended. In the adjacent cemetery I read on Robert Milling's tomb that he and his first wife were natives of Ireland. This, of course, aroused my curiosity; so, as we proceeded around the State, I visited the State Archives then presided over by Mr. A. S. Salley who was Editor of the South Carolina Genealogical and Historical Magazine. In Charleston, I searched for information in the Charleston Historical Society and several times afterwards in Clemson College Library. Thus began the lifetime hobby of family research since pursued by trips to the State Archives, to the Historical Society at Montreat, to offices of Probate Judges to look for wills, and offices of Clerks of Court to search for Land grants and

and deeds, and to quite a few cemeteries to read tombstone inscriptions, to say nothing of numerous visits to libraries seeking sources of information. I was fortunate to have access to the State Library of the Daughters of the American Revolution as it was housed for many years in the Library at Lander College in Greenwood, South Carolina, where I served for eighteen years on the Administrative Staff as Field Representative.

This has been a labor of love for me. True I suffered much frustration due to the fact that many of the earliest records of our State were destroyed in the Siege of Charleston during the Revolution and that sherman in his march through our State and neighboring states destroyed many county records, and fires destroyed the church records and cemetery records of Fairview Presbyterian Church in Greenville County and of Salem Presbyterian Church in Fairfield county, as well as of the Presbyterian Church in Drumbo, County Down, Ireland. A few parts of the puzzle are still missing, but I deem it wise not to delay longer presenting for your perusal as much of the picture as is now revealed to me. I expect to continue the pursuit as long as I live and trust that some of you will join me. If so, I can assure you many pleasant hours of adventure.

I wish to express my appreciation to my cousin, Dr. Robert
Nicholson Milling of Columbia who for several years has served as
Assistant Genealogist for our Family and who copied tombstones at the
Milling Family Cemetery on Jackson's Creek in Fairfield County and

who also checked many facts for us at the State Archives and at the Caroliniana Library at the University of South Carolina. He also made for my use a Zerox copy of the information which Dr. Chapman Milling of Columbia had compiled on our Family. We are grateful to Dr. Milling for making this data available though I had already collected much the same information over a period of forty years before I had access to his file. By the way, though we believe ourselves to be cousins, we have not yet been able to prove it.

I am especially grateful to another cousin, James Alexander Milling now of Moorestown, New Jersey, and his wife, Nan, for making a special trip to Ireland in search of records to substantiate some of the material I had gathered. They were disappointed to learn that most of the early Irish records had been destroyed by war or by fire. Too, the early tombs in the Presbyterian Church cemetery at Drumbo, County Down were illegible. They found a Milling plot with tombs dating in the 1800's, but none earlier. They did, however, find a small Milling cottage in Drumbo which was occupied by descendants of the Milling family as late as 1935. They met and visited with James and Jane Milling of Comber in County Down and Hugh Milling and wife of County Antrim. He is President of a linen manufacturing firm in Belfast. They enjoyed the hospitality extended them but were unable to establish kinship due to the fact that the Millings now in Ireland knew very little about their early ancestors. They were, however, members of the Presbyterian Church and believed that

their forebears came to Ireland from Scotland. James and his sister, Jane, said that their father and their sister, Flo, were horse racers and displayed trophies which they had won. Hugh, who lives in County Antrim about twelve miles out of Belfast, said that on a clear day they could stand on their portico and look across the Irish Charmally to Scotland. He said his forebears were named Hugh for several generations back and that all the members of his family had originally come from County Down.

I wish also to express appreciation to Mrs. Jack Yates of Gree da, Mississippi, a descendant of Captain Hugh Milling, who furnished me much data regarding his descendants and those of Margaret Nason Milling Bell who moved to Mississippi along with her uncle Richard Nason, from whom Dick Yates is descended. She gave me a listing of David and Ann Milling's children as found in Captain Hugh Milling's Bible and a copy of a plat of Robert Milling's home place found in the belongings of Richard Nason, his executor. She also furnished us a copy of a letter from Thomas Lauderdale to one of Captain Hugh Milling's daughters then living in Mississippi which gave much authentic information about the Milling Family, especially mentioning the fact that four of David Milling's sons came to America; namely, David, John, Hugh, and Robert.

Mrs. G. B. Richardson of Florence, South Carolina, furnished me a detailed account of the descendants of Dr. John Milling of Camden, South Carolina, and a picture of his home and of his tombstone and

that of his wife in "God's Acre", the Quaker cemetery in Camden,
South Carolina. Dr. John was a son of Captain Hugh Milling from
both of whom Mrs. Richardson is descended. She also located Captain Hugh Milling's home in the Jackson's Creek neighborhood of
Fairfield County. Many other family members have contributed assistance of one sort or another. I gleaned quite a few facts from
material assembled many years ago by my uncle, John Hugh Milling,
of Rock Hill, South Carolina which is now in the possession of his
daughter, Isabel Milling Carver (Mrs. James E.) of Laurinburg, North
Carolina. I am grateful to all members of our family who have shown
their interest and who have contributed to our collection.

The omission of many facts, yet unproven, is to be regretted, but time does not permit further research and inquiries. Finally I wish to express appreciation to Helen Milling Shands who made arrangements to get this history typed so that it could be durlicated

#### Chapter I

# Historical Background of the Milling Family

It is believed that our Milling forebears were originally from Scotland as they were all Presbyterians and since the Scotlish names of Hugh, Alexander, and David were passed down even to the present day.

Beginning in the reign of James I of England (about 1611) who was a Scot by birth, settlers were brought into Northern Ireland from Scotland and England in order to teach thrift to the Irish. We know from the tombstones of Hugh and Robert Milling, two of the earliest members of our family to America, that they were born in Ireland. They were of Presbyterian parentage, the sons of David and Ann Kellso Milling. There was an Archibald Milling mentioned as a Ruling Elder of the Presbyterian Church of Donaghadee, County Down, Ireland, in 1715. He may have been the father of David, born about 1718-1720.

According to Hanna's <u>The Scotch-Irish Families of America</u>,
"The great bulk of the Presbyterian settlers in Ulster were from Scotland."<sup>2</sup>

Hanna says:

"These proud and haughty strangers, with high heads and their new ways were hated as aliens and harried from the beginning by 'the wild Irish'. The hate and harrying of the Irish was returned, and with compound interest, by the proud Ulsterman. The Scots did not mingle to any appreciable extent with the natives. Belfast, though originally settled by English, soon became Scottish and remains Scottish to this day. The inhabitants of Counties Down and Antrim came from the southern highlands of Scotland. The Scotch people kept company only with the Scotch people, they are called Scotch-Irish from purely geographical reasons, and not from union by marriage. They are Scotch through-and-through and are always spoken of as Ulstermen. . . liberty of speech and conscience was definiately established in America by men of Scottish blood."

"Families that had distinct nobility came into Ulster from Scotland". 2

What were these Scotch-Irish Presbyterians like?

I quote from Presbyterian Women of South Carolina by Margaret Adams Gist, copywright 1929.

"Who are the Scotch Irish? The answer to this question takes us back to the year 1611, four years after Jamestown was settled,

when James I of England (James VI of Scotland) began planting Ulster with colonists from Scotland and the north of England, though the actual settlers were mostly Scotch. The plan was to put into the north of Ireland, Ulster, a Protestant population that would ultimately outnumber the Catholics and become the controlling influence in the Country. In order to do this the native Irish had to be ousted or dispossessed of their homes and land. These settlers were hand-picked men and women of the most excellent sort, not peasants, but mainly yeomen and artisans. Their minister went with them and Presbyterianism struck its roots deep and strong into Ulster soil. By the middle of the 17th century there were 300,000 of them in Ulster. Scotch energy, thrift, and steady conduct transformed Ulster into a garden. They were highly intellectual people believing in the schoolhouse as well as the church. In 1718 by a miscellaneous group of 319 men, only 13 made their mark. Fiske tells us 306 wrote their names in full. Nothing like that could have happened, he says, in any other part of the British Empire, hardly even in New England. The antipathy between the Scotch-Irish as a group and the true Irish as a group is perhaps unsurpassed for bitterness and intensity.

The flourishing manufacture of Ulster aroused the jealousy of rival manufacturers in England and legislation was passed in 1698 which seriously damaged the linen and woolen industries in Ulster and threw many workmen out of employment.

During 1704 and the following years severe disabilities were inflicted upon Presbyterians in Ireland. They were not allowed to hold any office higher than that of Petty Constable. By 1719 the hope that this tyranny was temporary had worn away and from that year until the passage of the Toleration Act for Ireland in 1782, the people of Ulster flocked to America. In the two years of 1773 and 1774 more than 30,000 came. Altogether between 1730 and 1770 probably half a million souls transferred from Ulster to the American colonies, making not less than one-sixth of our population at the time of the Revolution. In 1770 one-third of the population of Pennsylvania was Scotch-Irish - - - - It was chiefly Scotch-Irish troops that won the pivotal Battle of King's Mountain bringing to an end the American Revolution."

Read General McGrady's History of South Carolina. He says:
"The church was the place of meeting of the various public boards.

Almost invariably as soon as a neighborhood was settled, preparations were made for the preaching of the Gospel by a regular stated pastor, and wherever a pastor was located, in that congregation there was a classical school." McCrady concludes: "These newcomers who entered the province by the back door as it were, bringing with them essentially different ideas of Government of Church and State were to have a marked and decided influence upon the polity and policy of the coming State; were reluctant to enter the contest with the royal government inaugurated upon the coast, but goaded into it

by the folly and cruelty of the British Army, were to turn upon the invaders and, by their stubborn resistance and heroic conduct, to wrest from them the fruit of their success in the low-country. Reluctant again to enter the new Government established after the Revolution, they were to become the dominant force in the State, and to produce the men who were to influence in a great degree the future course of events in the United States 1 I am proud to say our Milling forebears were among this group who came to America about 1771 and were in South Carolina before the beginning of the Revolution. 2

#### Chapter II

David and Ann Kellso Milling evidently lived in or near prumbo, County pown, Ireland, and may have come to America along with their four sons: David, John, hugh, and Robert. I believe that they did as mobert was only six years of age in 1771 and would hardly have been sent so far away at that tender age. Too, a niece of these Milling boys, sarah Gordon, died enroute to america and was buried at sea. She would also have been quite young, and I believe was in company with her grandparents as her parents remained in Ireland. True, pavid and Ann may have come later than 1771. They could have come after the Revolution; but, knowing how close knit the families were, I believe they all came together.

Though the earliest record that I have of David Milling's presence in America was his purchase of a tract of 640 acres of land in the Fairview neighborhood of what is now Greenville County in May of 1784, just after the Revolution. We have proof of his sons, John and Hugh having fought in the Revolution. And perhaps their son, David, served also as he died in November, 1778.

The estate of a David Milling received payment from the new State Government for the loss of a waggon team and sundry goods in 1779, payment made March 24, 1780, of 186 pounds, fourteen shillings. The team was used to haul supplies to the soldiers during the Revolution.<sup>2</sup>

Children of David Milling, Senior, and Ann Kellso or Kelso Milling

- 1. Alexander Born 1739 Remained in Drumbo, County Down, Ireland.

  He died young leaving a wife and five children. The only one we know anything about was a daughter, Jane, who married William

  Lauderdale and came to America to the Jackson Creek area of

  Fairfield County in 1817. They had a son, Thomas Lauderdale, and a daughter, Mary, who married James Lemmon of the Jackson's Creek area. Daughter, Jane, married Yongue. Son william Mary ANF RUSSELL MEDICAL DOCTOR.

  Another son, or Pavid Lauderdale was Included.
- A daughter, Sarah Gordon, died enroute to America and was buried at sea. Since she was a little girl, I think she was coming along with her grandparents rather than with four unmarried uncles.
  - I think this helps to prove that David and Ann came to America. <sup>2</sup>
- David, Jr. Born 5-13-1745 Married Sarah Burney of Georgia, who was born in Scotland in 1747.<sup>3</sup> He bought 150 acres in St. Paul's Parish, Georgia, Sept. 1, 1773.<sup>4</sup> Their oldest daughter, Mary, was born in Georgia in 1772 and their daughter, Sarah, born in 1773.<sup>5</sup> He was in Charleston when he was a Charter Member of the Mt. Zion Literary Society founded in 1777. He died November 29, 1778.

We do not know where he is buried. 1 ( Forhaps in Charleston.)

- 4. John Milling (1-10-1748, 5-5-1788) was a Captain in Colonel Wade Hampton's Cavalry, General Sumter's Brigade, in the American Revolution. He was the first Clerk of Court of Fairfield County, South Carolina in 1785, and he was a member of the South Carolina House of Representatives in 1785. His wife's name was Jane. I think her surname was Wright as her grandaughter bore the name, Jane Wright Milling. Their oldest child, Mary, born in 1772, had no descendants. Their son, David Alexander, born in 1774 or 1775, had Milling descendants only through the daughter Jane Wright Milling who married David Milling of Jackson's Creek who came to America in 1823. John's youngest daughter, Sarah, born about 1776, married Daniel Faust of Columbia and had seven children (listed later). Captain John Milling is buried in the Milling Family Cemetery, near Lebanon Church, Fairfield.Co.
- 5. Hugh Milling (2-21-1752, 5-7-1837) was a Captain in the 6th Regiment Continental Line in the American Revolution. He had enlisted in the Militia in Charleston in 1774 and rose to Corporal, Sargent Major, and Captain in line of service. 5

He was appointed Sheriff of Camden District in 1785, and he was a member of the South Carolina Senate in 1799. Hugh was a practicing physician and an Elder in Jackson's Creek Presbyterian Church. He is buried in the cemetery of the Old Lebanon Rock Church at Jackson's Creek in Fairfield County between Winnsboro and the Lebanon Community. His wife, Elizabeth Burney Milling and several of their daughters are buried beside him. Elizabeth Burney was born in Scotland in 1762 and died at Jackson's Creek in 1829. Hugh lived until 1837.

- 6. Joseph or Josiah born 1758 We have no record of him; he may have died in childhood or at least unmarried. I believe his name to be Josiah since Robert Milling named his second son, David Josiah. He and Robert were the two youngest children and it was a custom about that time to name children for any deceased members of the family who had no sons of their own to carry on the name. Josiah must have died before the others came to America as Thomas Lauderdale didn't mention him in writing family history to a cousin in Mississippi about 1873 or 1874.
- 7. Robert born 1765, died October 25, 1828 He was only six years of age in 1771 when it is supposed the four brothers came to America. This is one reason I think his parents came with them; I cannot imagine their allowing a six year old to come without them.

Robert was a Justice of the Peace of Fairfield County in 1705 and he was a large land owner and had many slaves. His home was near Salem Cross Roads in Fairfield County. He married first in 1811 Margaret Nason who was also born in Ireland. She was a sister of Richard Nason who married Captain Hugh Milling's daughter, Margaret. Robert was 46 years of age when he married for the first time. His wife, Margaret Nason Milling, died in 1814 at the age of 35 years, leaving an infant daughter named for her mother, who was reared by her uncle, Richard Nason, and his wife. Robert was married the second time in 1816 to Mary Russell, daughter of James Russell of Henry County, Georgia. They had five sons as follows:

Hugh Alexander (9-8-1817, 4-28-1873)
David Josiah (5-28-1819,11-28-1848)
James Russell (3-24-1821, 11-6-1844)
Robert Means (11-3-1822, 1-5-1848)
John McKibben (3-4-1825, 6-11-1864)

A David Milling, whom I believe to be the father of David, Junior, John, Hugh, and Robert was granted a tract of 640 acres of land by the State of South Carolina in the Fairview Section of 96 District, this area now in Greenville County, on May 21, 1784, as were John Milling, Hugh Milling and David, son of John Milling. Mary Milling was granted 400 acres there on June 12, 1784, and Sarah Milling was granted 300 acres there on January 21, 1785. Mary and Sarah were the

daughters of David Milling, Junior, who had died in 1778. Each girl was 12 years of age at the time of her grant. These grants are all recorded in State Land Grants in the Archives in Columbia. I knew to look for the plats in Greenville County because they were all on the Branches of Reedy River.

They were granted by the State of South Carolina for specified sums paid in sterling. John Milling sold his entire estate, including home, outbuildings and equipment to Alexander Peden in 1786. It is the Dr. Stewart place, though the old log home was back of the present Stewart house. He bought a tract at Jackson's Creek in Fairfield County that same year near his brother, Hugh Milling, who had built his home there in Jackson's Creek neighborhood in 1784. John and Thomas Means sold the tracts in Greenville County granted to Mary and Sarah Milling in 1797 and 1792 respectively, and a David Milling of Newberry District sold 200 acres there in 1809 to Robert Peden including house and outbuildings. These transfers are recorded in the office of the Clerk of Court in Greenville County. I was unable to find what disposition was made of the other acreage.

David's tract had a large log house on it when Robert Peden acquired it. 3 I do not believe Captain Hugh Milling built a house


This information was given me by Lila Peden Sprouse, a descendant of Robert Peden.

To David Milling - Granted by the State of South Carolina on payment of 64 pounds sterling, 640 acres in 96 District on the Branches of Reedy River - Surveyed and laid out to David Milling on May 21, 1784.

This is now the Doctor Stewart place.

This plot is across the road from the house on David Milling's dand and adjoining some of the David Milling property which is now owned by Miss. A. Grisprouse (Lila Peden). She is a descendant of Robert Peden to whom a David Milling sold 200 acres of his tract.

This same John Milling was in Fairfield County in 1777 when he was a charter member of the Mt. Zion Literary Society. He was in the American Cavalry at that time.

There was a large log house built on David Milling Senior's acres in the Fairview neighborhood of Greenville County. It was a two story house having two large rooms and a wide hall downstairs and two large rooms upstairs. The kitchen was another log building in the back yard. I think David and Ann and their youngest son, Robert, who was 19 years of age at this time, occupied this house and perhaps for a while the widowed daughter-in-law, Sarah and her two little girls, Mary and Sarah. Robert Peden later built a large frame house around this log house. An "L" shaped two story addition was added for dining room and kitchen and additional bed rooms and a large porch was added across the front. This information and picture of the remodeled home were given me by Robert Peden's descendant, Lila Peden Sprouse. Strangely enough, she and I were classmates at Lander College, where we graduated together in 1919.



Item I give to my son, Robert Milling, the following negro slaves:
to wit; Betsy, Sam, Jæfferson, Amy(child of Dina), Sylvia, with Milla and all, with the future increase of the said female slaves to my said son, Robert and his heirs forever.

<u>Item-</u> I give to my daughter, Isabella Owens, the following negro slaves, to wit; Henry, Tom, Rebecca, Andrew, Soloman, and John, with the future increase of the said female slave to my daughter, Isabella, and her heirs forever.

Item— I give and devise to my son Robert Milling all that part of my plantation wherein I now reside, which is contained within the following tracts; that is to say two hundred acres conveyed to me by Robert Ellison, one hundred and fifty acres conveyed to me by Adam Blair, and a piece of land about thirty acres adjoining the above lands and David Alston's land, being part of tract granted to John Buchanan, to my son Robert and his heirs forever,

Item— I give and devise to my grandsons, John Nason and Richard Nason, Jr., all my part of a tract of land situated in Spartanburg District, known by the name of the Pacolet lands, which part has been laid off for me by commissioners, to my said two grandsons and their heirs forewer.

# Obituary of Capt. Hugh Milling -- May 7, 1837 An Old Revolutionary Officer Gone

Died at his farm, on Jackson's Creek, in Fairfield district, Capt. Hugh Milling, an officer in the army of the Revolution, born at Drumbo, County Down, Ireland, on the 21st February, 1752. He emigrated to America about the year 1771, and was a resident in Charleston in the year 1774, when the first Revolutionary movements were made in that city. At that time he joined a company of Grenadiers raised by Capt. McCall, by whom the British Arsenal was forced open, and that company and others supplied with arms. In 1775 he became first sergeant in a company of Grenadiers commanded by Charles Cotesworth Pickney; in 1778 was commissioned first lieutenant in the sixth continental regiment of South Carolina, and in 1779, a Captain in the same regiment. His military services were arduous and incessant, ranging over an extensive field of action; he was engaged in the first and second battle of Fort Moultrie; at the battle of Stono; at the siege and storming of Savannah; in the war that was carried into the Cherokee nation in Georgia; in Florida and in unsuccessful expedition against St. Augustine. The continental regiments of South Carolina became so reduced in numbers by disease and battle that it was necessary to consolidate them. This measure deranged the officers of the sixth regiment and Captain Milling served as a volunteer at the seige of Charleston. Some short time before the city fell, he was ordered by Governor Rutledge to endeavor to make his way through the lines of the enemy and raise men in the back country and come down in the rear of beseiging army. In this, together with some other officers, he succeeded; reached the upper districts and was engaged in this service when he was taken by a p rty of Tories and lodged in Camden goal, from whence he was sent to Col. Balfour, the British Commandant in Charleston, and from thence to Hadrel's Point where he remained a prisoner

under parole to the end of the war. Thus from 1774 to 1781 he was constantly with arms in his hands and actively engaged in the revoluntionary service. The peace of 1783 found him on his farm at Jackson's Creek, where he continued to reside the remainder of his days, cultivating the soil, practicing medicine, and otherwise actively employed in providing means of support for wife\* and eleven children, and in the exercise of that kindness and benevolence that gained for him the esteem and respect of all around him. For upwards of forty years he was a member of the Presbyterian Church and had the satisfaction of seeing all his children grown up and most of them become members of the same church.

In his last years he was tried by many afflictions and severe dispensations of Providence in the death of his wife, one son and six daughters, following each other to the grave in rapid succession

He was, however, enabled to bear his trials with fortitude and resignation, supported by the hope of a Christian -- a hope that never failed him in his last moments.

During his last sickness (a period of about two weeks), he retained in a degree remarkable for his years, both his physical and mental energies and closed his long and useful life on the 7th May, 1837, 85 years, two months and sixteen days.

#### Chapter IX. Robert Milling and His Descendants

Robert Milling of Salem Cross Roads, Fairfield County, South Carolina, was born in 1765 in Ireland, according to a statement on his tomb in Salem Presbyterian Church Cemetery. He died in 1828 at age 63 years which would place his birth date at 1765.

Someone recorded in Captain Hugh Milling's bible that Robert was born in 1755, but I think that was a mistake and recorded after Hugh Milling's death as it states" brothers of Hugh Milling that is dead."

The photostatic copy I saw reads :

" Children of David and Ann Milling:

Margaret, born 1741, married James Gordon and remained in

Ireland. Brothers of Hugh Milling that is dead. Alexander- born 1739, remained in Ireland David, born 5-13-1745
John, born 1-10-1748
Robert, born 1-5-1755
Joseph. born 1758

Hugh was the fourth son of David and Ann, born 2-21-1752."

This leads some to believe that our Robert, born 1765, was not

Captain Hugh's brother. I believe that Robert was David's

youngest child and that he was born in 1765 as his tomb states.

I also believe Robert was Hugh's brother for the following reasons:

1. Robert Milling in his will signed in 1828 left a legacy of \$100 to his nephew, David Milling. I believe this to be David Thomas, son of Capt. Hugh. John's son, David Alexander, had died in 1813.

There were no other David Millings in the area at the time.

However, another David Milling purchased one thousand acres in the Jackson's Creek area a few years after this. David Milling

of Jackson's Creek who came to America in 1823 and married John Milling's grandaughter Jane Wright Milling was always referred to as the David who was not our relative. The other David Milling living at that time was Robert's own son.

- 2. Captain Hugh Milling, who died in 1837, willed \$ 250 to Hugh Alexander Milling, son of Robert deceased. (I think he was returning the favor)
- 3. Thomas Lauderdale, whose mother was a niece of these Milling boys, wrote in a letter to one of Hugh's descendants in Mississippi in 1873 "Four of the old man's sons (David Milling's sons) came to America; David, John, Hugh, and Robert."
- 4. Hugh Milling was a witness to Robert Milling's deed to his place purchased in 1803.
- 5. Hugh Milling, John Milling, and two David Millings owned property in the same neighborhood as did Robert Milling in the corner of Fairfield County between Winnsboro and Camden. There was no other Robert Milling living in that area at the time.
- 6. Robert Milling's only daughter Margaret Nason Milling was reared by Hugh Milling's daughter Margaret "Peggy" Milling Nason and her husband, Richard Nason, who was a brother of her deceased mother.

  Robert had no sister in this country and we assume his mother had died before 1814. I think Richard Nason's wife was more willing to rear the

- Baby since the child was her own first cousin. She had a daughter only three months old at the time and they were reared as sisters.
- 2. Captain Hugh Milling once asked his nephew John Milling to take his sword to have it repaired. This was a joke passed around in the family that when the old Captain brought out his sword and said, John I want you to take this sword----" that John jumped to the conclusion that his uncle was going to give him the sword, but the old man finished his sentence saying" and have it repaired for me. " John McKibben Milling, son of Robert, was the only John Milling living in that area at the time.
- 3. Robert Milling and both of his wives are buried in Salem Church Cemetery. The land for the church and cemetery was given by Sarah Milling Means and her husband Thomas Means. She was a daughter of David Milling, brother of Hugh and Robert. When Robert settled at Salem Cross Roads he acquired property near the Means brothers, and Robert named one of his sons Robert Means. This indicates that he was David Milling, Junior's brother.
- 4.. Robert named his first son Hugh Alexander. These were the names of two of his brothers.)
- 5. His second son he named David Josiah. (This was for two more brothers.)
- 6. His next son was named John for his other brother.

- 12. He had two other sons, one named Robert Means and the other for his wife's father. James Russell .
- 13. Captain Hugh Milling named his sons for his brothers: David
  Thomas, John Hugh, and Robert.
- 14. Had Robert Milling, Senior, been born in 1755 he would have been old enough to fight in the Revolutionary War and we can find no record that he did.

The above reasons comprise satisfactory proof, so far as I am concerned, that our Robert Milling was born in 1765 and was the youngest son of David and Ann Kelso Milling and brother of Alexander, Margaret, David, Jr., John, and Hugh.

Robert born in 1765 was only 11 years old when the Declaration of Independence was signed so was not in the war. After the war ended, his family members purchased land in the Fairview neighborhood of what is now Greenville Gounty in the year 1784. Shortly thereafter Hugh and John moved to Fairfield County and David's widow followed suit and purchased a tract near theirs. Robert didn't acquire land in Fairfield County until 1803. I think he was still living with his parents in the Fairview neighborhood and accompanied them to Fairfield County in 1796 when David, his father, purchased a tract of 400 acres there. Robert probably continued to live with the old couple as he was the youngest child and still unmarried. He didn't marry until the year 1811 at the age of 46.

This was evidently composed by her son, James Russell Milling, who was known as somewhat of a poet. He never married and died in 1844 only three years after his mother's death.







Robert Milling owned 580 acres in the home tract though he may have had some other lands unless he disposed of them before his death.

Robert's will recorded that the tract of approximately 150 acres bought from Woodward (actually 180 acres) was left to his daughter Margaret Milling who was the child of his first marriage to Margaret Nason, sister of Richard Nason, who was named executor of his will and guardian of his children. Richard Nason was to manage Robert Milling's estate for the benefit of his second wife, Mary Russell Milling, daughter of James Russell of Henry County, Georgia, and of his five sons by this marriage. The eldest of these sons, Hugh Alexander was only eleven years of age at the time of his father's death in 1828.

Richard Nason reared Margaret Nason Milling in his home as he was her mother's brother and had married her first cousin, Margaret Milling (Peggy) daughter of Captain Hugh Milling.

He discharged faithfully his responsibility as executor and guardian but soon after Hugh Alexander Milling became of age in 1838 he settled the estate and moved to Mississippi with his family and that of his niece Margaret Milling who had married William Bell, who was probably a son of James M. Bell and Jane Montgomery Bell. Born 1803 in South Carolina, died in 1881 in Mississippi

A Charles Bell owned property adjoing Robert Milling's home place. See plat above.

In the name of God Amen, I, Robert Milling of the district of Fairfield, do make and ordain this my last will and testament in manner following: That is to say-First - I give and devise to Richard Nason, my executor herein (after) named - the dwelling house wherein I now reside with the appurtenance and one hundred acres of land around the same, and a negro woman named Miney and her future increase, a: horse and ridimg: chair and harness, together with whatever property my wife Mary Milling had at the time of her marriage with me, to have and to hold the same in trust for and to the sole use benefit and behoof of my said wife Mary Milling for and during the term of her natural life and from and after decease to the use benefit and behoof of all my sons and their heirs forever.

Hilling: a tract of land I purchased from Burbage Woodward containing 150 acres more or Iess and a negro woman named Jenny and her children named Charlotte and Eve. Also, a chest of drawers, a birch bed stead and furniture which were ner mother's, and her deceased mother's chest with its contents to said daughter Margaret and her heirs forever. Item 111. I give and devise to my nephew, David Milling, the sum og \$100.

Item 10. I give to Robert Milling: Gamaca somecket blible.

David's Realms and Mart's sersalms to be purchased by my executor and delivered to bib.

Item V. I authorize my executor herein after named, to cause that a marble slab or tombstone be placed over the graves of my first wife and myself.

support, and education of my said sons until the eldest son shall attain the age of 21 years, and that so long as my said wife, Mary Milling, shall remain my widow, and shall reside in my dwelling house in care of my said sons so long she shall be entitled to her support and maintenance in common with my said sons.

Item VIII. It is my will and desire that when my eldest son shall attain age 21 years, my executor shall cause the estate herein devised and bequeathed to my said sons, to be valued by himself and three respectable neighbors and an equal division of the same according to the said valuation to be made among my said sons share and share alike which division so made shall be as binding on my said sons as if I had made it myself.

Item IV. In case my daughter Margaret shall die before she attains the age of 21 years or marriage then the property herein given to her shall be equally divided among my said sons share and share alike — and in case any of my said sons shall die before attaining the age of twenty-one years or marriage, the share or shares of my real and personal estate herein given to such of my sons as shall die before attaining age of twenty-one or marriage shall be equally divided among my surviving sons and my daughter Margaret share and share alike.

Item X. I do hereby constitute and appoint Richard Nason sole guardian of the persons and property of my daughter

Margaret and all my sons during the minority of them or any of them.

Lastly, I do hereby nominate, constitute, and appoint my friend Richard Nason sole executor of this my last will and testament hereby revoking all wills by me heretofore made and declaring this to be my last will and testament. In witness whereaf I have here unto set my hand and seal this sixteenth day of September in the year of our Lord one thousand eight hundred and twenty-eight in the 53 year of the independence of the United States.

Robert Milling had served as Justice of the Peace for Fairfield County. This fact recorded in Book E. Ordinary's Office. Volume 7 page 2.

His oldest son, Hugh Alexander got the house and a portion of the land surrounding it. His youngest son, John McKibben, must have received the portion in front of Salem Church as his son, Martin, later lived there when I was a child: it was pointed out by my father every time we passed it enroute to Salem Church.

We will now discuss Robert Millings Descendants. This is the branch of the family I know the most about as 1 am one of his descendants and 1 am now in possession of his Bible which was passed down to his son Hugh Alexander Milling and to my father David Madison Milling.

The birth dates and death dates of all of Robert's and Hugh Alexander's children are recorded in this Bible except the death date of Robert's daughter who moved to Mississippi along with her Uncle Richard Nason about 1838 - 1840 after her father's death and her marriage in 1835 to William Bell son of James Bell and Jane Montgomery Bell.

The letter from Thomas Lauderdale of Fairfield County written in 1873 to Isabella Milling Owens of Mississippi, youngest child of Captain Hugh Milling, referred to Hugh Alexander Milling, son of Robert Milling, as "your cousin Hugh." I quote: "We lost your cousin Hugh which leaves a vacuum there. (Meaning that Hugh was the last of his immediate family.) He was 25 years yuonger than the writer( Thomas was 81 at the time). He was an extremely nice farmer and made out very well, but could not adapt himself to the free men to get along satisfactorily. " This seems to indicate that Robert Milling and Hugh Milling were brothers and that Isabella and Hugh Alexander were first cousins. Thomas Lauderdale was a first cousin once removed from both Isabella Owens and Hugh Alexander Milling. Thomas' mother, Jane Milling Lauderdale was a daughter of Alexander Milling of County Down, Ireland, brother of Captain Hugh and Robert.

In another letter to Dr. John Milling of Camden written in 1861.

on the occasion of the death of John's wife, Thomas Lauderdale wrote:

"Hugh is a kind friend and neighbor; I have always bee much pleased with him. He has a gentility about him that is calculated to command respect. I rate him a superior man to his father everything considered. Hugh's disposition is amiable; he is a high minded honorable man who would be very careful not to give offence to any man. He is a delicately constituted man and has experienced severe affliction and has been confined to his house a good deal at this time.

John (his brother) is in camp; he has a suitable female with his children. Hugh's son stays there at night to help her

and pays some attention to his hands. "Thomas says he took John's letter concerning his wife's death to let Hugh read it. He states, "Hugh was seriously affected on discovering its contents; he mentioned the pleasure her association gave him and how much he was pleased with her disposition." I often heard my father say that when his father, Hugh Alexander Milling, died he called his sons around him and counseled them "Quit ye like men!" This made quite an impression on my father who was 22 years of age at the time in1873.

Hugh Alexander did not fight in the War Between the States;

he was in ill health and had a large family to support. He had

permitted his oldest son, James Alexander, to enlist when he was

only fifteen. This left nine younger children at home. Sherman in his march through that section of South Carolina destroyed much of his property and took all of his livestock.

Margaret Tims Milling named a son Vincent Brown Milling; he died young. Her sister Eliza McFadden of Chester named a son Vincent Brown McFadden. I often heard my father speak of Brown McFadden. He also talked of visiting the Hughes and McFadden families of Chester County. Vincent Brown, their father, lived in Chester County; his will was probated there, October 1856. In it he names the following children:

Margare Tims evidently felt closer to the two sisters nearer her own age.

One paragraph of the Vincent Brown will reads:

"I will that my negroes be sold by my executor and the sum of money they bring be equally divided among my children; also, that all my personal property and chattels be likewise disposed of and the money divided equally among my children."

I judge by that statement that his wife had died previously.

The will was signed September 25, 1856 and probated on Oct. 6th.

I always heard that my grandfather, Hugh Alexander Milling, met my grandmother on an occasion when the Browns stopped one night at the Milling home at Salem Cross Roads while enroute to visit relatives in Georgia. It seems a logical story as they would have been traveling by horse and buggy and had reached

Broad River which had to be crossed by Ferry just about a mile or two beyond the Robert Milling home at Salem. Hugh Alexander Milling and Margaret Tims Brown were married in 1841 the same year that his mother died.

Dr. James R. Boulware's widow, Eliza Milling Boulware, then married Archibald James Hamilton (born 8-4-1830, died 12-27-1895).

He was a son of William Hamilton and Nancy Russell Hamilton who was a sister of Mrs. Robert Milling, Eliza's grandmother. The Archibald Hamiltons lived near Salem Cross Roads on the right of the dirt road leading toward Chester when they were first married and while their children were young.

About the year 1895 they moved to White Oak in the same county but on the railroad between Columbia and Chester. After his death Eliza moved to Greenwood for awhile and ran the Greenwood Hotel. Her proud brothers thought that to be beneath her dignity; so she gave up the hotel and moved to Rock Hill where she died in 1902. She and her husband, Archie were much beloved by the other members of her family as she mothered the younger single members of her family after her mothers death in 1887. David, William, Nora, and John Hugh were still single. Nora and John lived with her until Nora married and John found employment in Rock Hill.

During the war he met the Brooks brothers from Scotch Cross, in what is now Greenwood County. He served as sharp-shooter and saw many privations and had many harrowing experiences according to a diary which he wrote after being paroled near Greensboro, North Carolina on May 2, 1865. He was listed as 1st Corporel, Company E, Third Regiment, South Carolina Infrantry, C.S.A. He had a "Yankee" blanket in his possession from which he had a Jewish taylor make him a pair of pants to wear home.

Sherman had gone through Fairfield County plundering and destroying in his path. On arrival home "Jim" discovered that his father's place had been stripped of mules for farming: so he gathered together the jewelry his sisters had managed to save from the mauraders and rode on horseback to the Brooks plantation near Scotch Cross to trade the jewelry for mules to use in farming his father's plantation at Salem Cross Roads, in Fairfiel County.

On his trip to Greenwood he met Miss Emma Brooks whom he married in 1873. They lived at Salem until his mother died in 1881 when they moved to Greenwood County. Her mother had died in 1877 and Emma inherited property near Greenwood. This is how the Millings got to Greenwood County.

He and James Richmond, husband of his cousin Sue Milling, who also lost a leg in service, sometimes rode the same horse in order to have a leg on each side of the horse and a foot in each stirrup.

Jennie said "Howe Lemmon and I had the same grandma but not the same grandpa, though grandma Millings husbands were both named David Milling and both descended from the Millings of County Down, Ireland."

Jennie's mother Mary Lemmon was sister of Howe's father, Robert Y. Lemmon.

Howe Lemmon, born 1803 now is his 90's is in possession of his grandfatner, David Milling's Bible and of his Naturalization papers acquired in 1827. He says he will probably leave them to his son Robert Howe Lemmon of Whitmire, S.C..

His other children live away from S.C., James lives in Colorado, Margaret in Washington, and Agnes in Iowa.

- IV. Robert Milling's son James Russell Milling never married. He died at age 23, on November 6, 1044. He was somewhat of a poet.

This material on Martin Milling's descendants was furnished me by his grandaughter, Helen milling Smoak of Columbia, in August of 1968. I have no other source of information on John McKibben milling's descendants; I suppose the children were scattered due to the early death of their parents. The mother died, in 1860, and the father was killed in the war in 1864. Since the son Martin Milling lived at Salem and his son Joe Wearing Milling lived in Winnsboro it was possible to trace their descendants better.

## Chapter X. Other Milling Families Who May Be Descendants of David and Ann Kelso Milling.

There were two other Milling families who came to South Carbaina later. These were the families of John and Thomas Milling who came in 1812 and 1842 respectively. They were evidently related to the Millings of South Carolina as they settled in Fairfield County near Captain Hugh Milling's family and that of Jane Milling Lauderdale who came in 1817. It is quite possible that John and Thomas were sons of Alexander Milling who remained in Ireland and died in 1773 leaving a wife and five children one of whom was Jane Milling Lauderdale.

The James Milling living in Comber Ireland today may have also been a descendant of Alexander. I have been unable to get the names of Alexander's sons. Hugh Milling of County Antrim said all of his ancestors were named Hugh and James of Comber in County Down said all of his had been named James as far back as either of them could trace. Perhaps Alexander's five children were Hugh, James, John, Jane, and Thomas. The name Thomas was passed down to Captain Hugh Millings oldest son whose name was David Thomas, born in 1782.

Darlington, John was a schoolmaster who taught for many years in
Fairfield County, S.C. He came from Ireland. We do not know the
name of his wife though she may have been the Rosanna Milling recorded in the Session Book of Zion Presbyterian Church, Winnsboro.
John's children were:

- A. Mary, born in Ireland M. Zachariah Price of Winnsboro
- B. David Claudian, born January 31, 1812, immediately after his parents arrived in Charleston, S.C.
- C. John, married and moved to Florida
- D. Whitfield Ross, moved to Augusta, Georgia
- E. Samuel, died in early life, unmarried
- F. Jane, M. a Mr. Donnegan of Barlington. She moved her member—ship to Darlington Presbyterian Church in 1837.
- G. Anna, married a Mr. Morris of Charleston, left issue David Claudian Milling moved to the PeeDee Section of the State. He moved his church letter to the Darlington Presbyterian Church in 1832. He was active in that church until suspended for dancing in 1845. Being quick tempered and high-spirited he never reunited with the church though he often expressed a desire to unite with the Episcopal denomination, the difficulty being that there was no congregation of that sect in his community at the time. He was married twice; his first marriage was to Elizabeth Bascot of Huguenot ancestry.
