Thomas Blair

In the Name of God Amen:- I Thomas Blair of the State of South Carolina & County of Chester Being very sick & weak of body but of perfect Mind and memory thanks be given Unto God Calling Unto mind the Mortality of my body & Knowing that/<sup>it</sup> is appointed for all men once to Die Do make and ordain this my Last will & Testament that is to say principally and first of all I give and Recommend my Soul Into the Hand of Almighty God that Gave it, and my body I Recommend to the Earth to be buried in Decent Christian Burial at the Discretion of my Executors, and as touching such Worldly Estate wherewith it has Pleased God to bless me in this Life I give Divise & Dispose of the same in the following manner and form:

First I give and Bequeath Unto Margaret My Dearly Beloved wife one bed and furniture & Her wheel also one Cow & Calf and a small bay Horse. Also to have Lawfull Genteel Maintenance During Her whole Life. also one Horse & Cow to be kept for her use, the Whole of Which is to be Maintained Equally betwixt my Two sons viz Thomas & William the one half of Her maintenance off Thomases plantation the other off Williams:-

Secondly I give & Bequath Unto my Son Jas. blair five shillings & no more; I give and Bequeath to his son Thomas blair one pound five shillings Worth of Hogs:-

thirdly I Give & Bequeath Unto my son John Blair five Shillings and no more:- Fourthly I give & bequaeth unto Alexander Walker five shillings & no More:-

Fifthly I give and bequeath unto my son Thomas blair five shillings and no more:-

Sixthly I Leave and bequeath/to my Daughter mary blair one

Claims one mare & foal one Dark Bay Horse ~~XXXX~~ Also the Wag-  
 gon With all the Iron tools belonging to the plantation & with  
 the Remainder of the Cows & Hogs and sheep and also I ispower  
 him to Collect all my Debts & Discharge all my Creditors.-----  
 Lastly. I Likewise Constitute make and ordain my sons James  
 & William Blair to be the sole Executors of this my Last will  
 & testament and I Do hereby utterly Disallow Revoke and Dis-  
 annul all & Every other former testament wills Legacies Be-  
 quests & Executors by me in any ways before maned willed & be-  
 queathed Ratifying & Confirming this and No other to be my Last  
 will & testament in witness Whereof I Have hereunto set my hand  
 & seal this fourteenth Day of September in the year of our  
 Lord ---1795

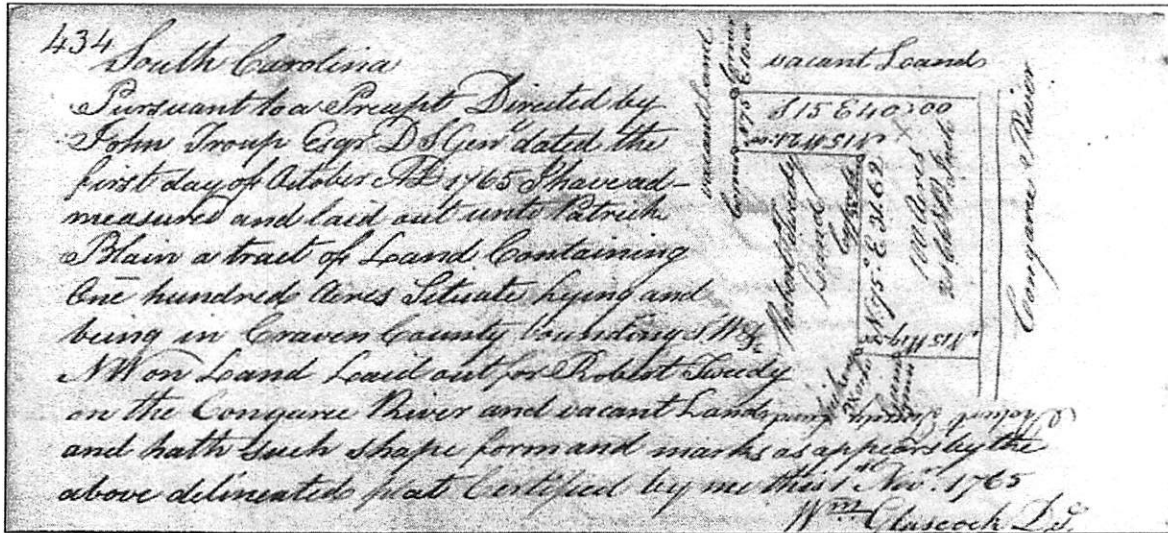

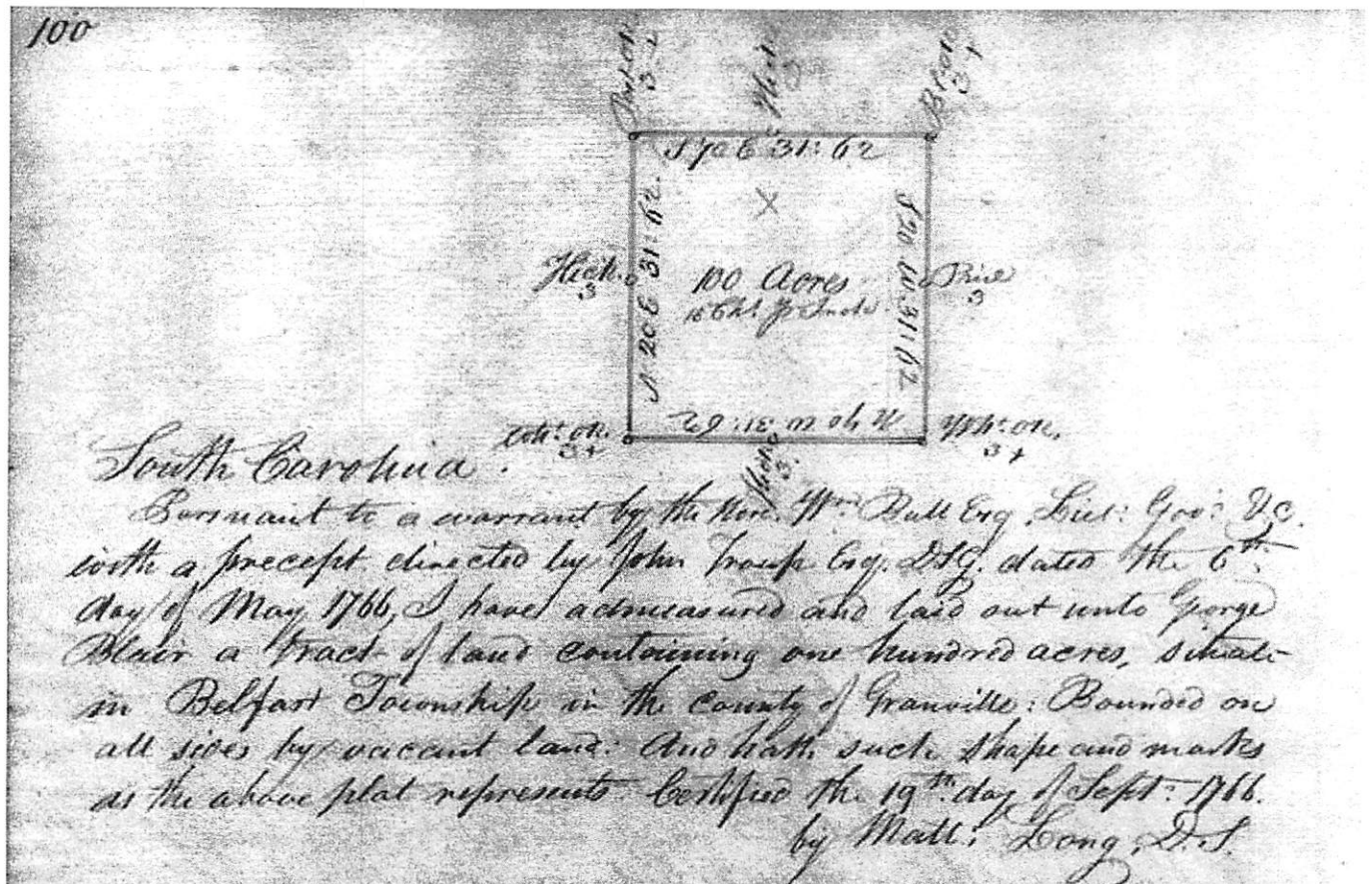

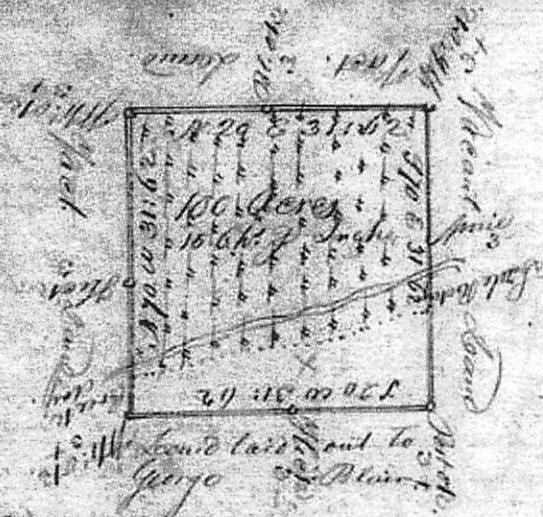

In pursuance to a warrant by the Honorable W<sup>m</sup> Bull Esq. Lieut. Gov<sup>r</sup>.  
 Ye. with a precept directed by John Traup Esq. Esq. dated the  
 6<sup>th</sup> day of May 1766, I have admeasured and laid out unto William  
 Blair a tract of land containing one hundred acres, situate in Belfast-  
 Township, in the County of Granville: Bounded on the E<sup>o</sup> by land  
 laid out to George Blair, on all other sides by vacant land. And  
 hath such stakes and marks as the above plat represents.

 Math. Long, Esq.

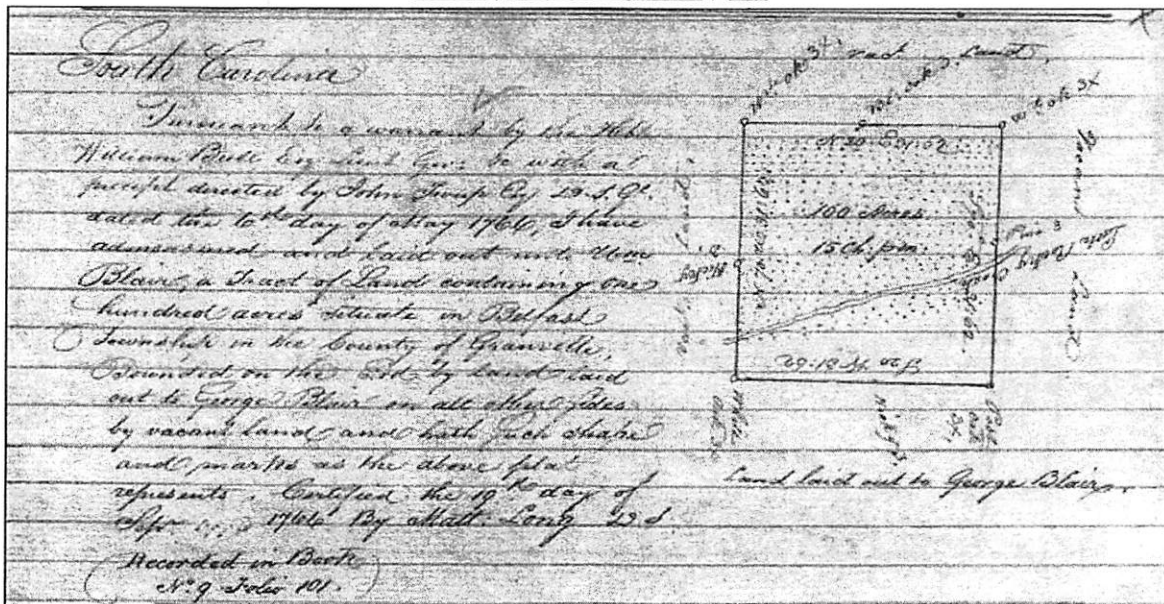

I Pursuant to a warrant to me directed by John Boman Esq. Sheriff of Craven County. We and dated the 4<sup>th</sup> day of February 1772. I have measured and laid out with William Blair a Plantation or Tract of Land containing one hundred fifty Acres situate and being in Craven County and on both sides a Branch of Tiding Swamp Branches of Ochee River. Bounded to the East by land said out to & land granted to John Ferguson Charles Ferguson, West by land granted to John Ferguson and East by vacant Land, having such Markes, fencs and other as the above that represents. Certified this 10<sup>th</sup> day of Feb: 1772.
